A BILL TO CREATE THE SUPPORT SERVICES PLANNING AD HOC  
COMMITTEE

1           WHEREAS, the Staff Senate is the representative body for the staff at the  
2           University of Wyoming; and

3           WHEREAS, the planning that is taking place on campus will affect staff;  
4           and

5           WHEREAS, the administration will be asking for the Staff Senate's input  
6           during the process; and

7           WHEREAS, the response periods during which Staff Senate's input will  
8           be requested may not coincide with Staff Senate's regular meeting;

9           THEREFORE, BE IT RESOLVED that the Support Services Planning  
10          Committee be created with the following function, powers and  
11          composition:

12          FUNCTION—To review the academic and support services planning  
13          processes as they develop on campus and to report these findings to the  
14          full body of the Staff Senate. It will also make comments to be forwarded  
15          to the appropriate authorities expressing Staff Senate's opinion on the  
16          plan during the process. This committee will dissolve at the end of the  
17          planning process.

18          POWERS--To appoint and charge ad hoc subcommittees (each  
19          subcommittee will have at least two members from the committee.

20          COMPOSITION—This committee shall have as many staff members as  
        feel they want to participate, with only Senators having voting power.
