- III. Administration reports
  - a. Vice President of Administration Representative
    - a. Janet Lowe- Budget bill done awaiting governor signature.
    - b. 1% retention incentive has been approved. Working though distribution will be paid in October, does require satisfactory performance evaluation, (Due date 3/31). For UW means minimum score of 3.0 or higher. Running through the costing models, separate check or add to pay check. Costing model looks like will have the least negative impact to just add to payroll instead of separate check.
    - Budget and AML bill will help formulate the budget that will go to the board later this year.
    - d. Retirement contribution increase was passed by the legislature. Will be going through the legislation to get the numbers right and they think 75/25 for next 3 years.
  - b. Human Resources Director, Richard DelaCastro
    - a. 100% grant funded not subjected to performance evaluation requirement, faculty, and probationary employees. All still eligible for 1% bonus. Have to be employee as of July 1<sup>st</sup> of 2013, and as of the date the pay is sent out. (hired in August not eligible) and if you quit before payment is made you are not eligible. Very preliminary at this time until Executive council meets tomorrow and then they will vet with the legislative to make sure interpretation is correct. (commenting in conjunction with VP Lowe)
    - b. Employee handbook
      - III. Meeting with HR folks and compiling the final version of recommended changes to the handbook, hoping to meet with exec council and president and get the final version passed. Once it's adopted, HR will be getting the information in the hands of the employees.

c. House bill 79 that formalized in the state code, employers may on an employee's termination not pay out the accrued vacation. UW will not be acting on that bill, they will pay out the vacation accrual upon termination. No change to comp time, it will be paid at termination.
