## IT News

### New wireless:

Since this semester, everyone has noticed that we have a new wireless system (UWyo and UWguest), and the old ones (uwyo and uwpeap) are no longer available. As the name implies, UWguest is mostly intended for guests who have no login account with UW, and therefore it does not provide printing privileges. For XP users, UWyo requires a little configuration (see Edward if you do not know how it is done), but Vista seems to connect to UWyo without the need of prior configuration.

### A Notice to Mac Users:

It has come to my attention that some Mac users at the College of Law have incorrectly installed the printers on their laptops, causing errors in the Pcounter system which updates your print quota every time you print. So all Mac users are encouraged to see Edward to fix this issue.

### Did you know you can access the UW lab from home?

Law students use their personal laptops more often than the labs. However I thought it would be beneficial for everyone to know that we actually can access the lab PCs from home or anywhere in the world. The only thing you need is a computer with internet access and then you browse to <http://microlab.uwyo.edu/uwsremote>. Once you have logged in you can use any software available in the lab or work remotely on any document you have stored on your UW network drive (commonly known as H: on Arthur server). I believe everyone can find at least one instance where this functionality can be handy.

## Read and Return Shelf

Feel like reading a fun title without doing a library search? Try browsing our new Read and Return shelf outside the library doors. Just take a book home and return it when you have finished reading it. No need to check it out. We are also accepting donations to this collection at any time. ## The Library and Exams

As we approach finals time, please remember that the library is a quiet study area. Cell phone conversations and other personal conversations should be removed from the library. Keep in mind that we have added an additional study room outside the main library, across from the circulation desk. Conversations at the front desk and continuous or unnecessary bell-ringing can be very distracting for those using that room, as well as for library staff.

Speaking of study rooms, reservations for group study are limited to two-hours per study group and can be renewed only if no one else is waiting for the room. The deans reserve some of the library study rooms for exam takers, so group study space is especially impacted at this time of the semester, and for that we apologize.

Access to the exam page has changed a bit, too. A password is no longer required. Select Exams File from the law library page at <http://uwyo.edu/lawlib> and enter your university student ID and password.

**Hein Online** is continually expanding its content. We have purchased access to the American Law Institute Library, English Reports, the Foreign & International Law Resources Database, State Session Laws, U.S. Congressional Documents, and the World Trials library.

Though content is limited today, **Human Rights Documents Online** will ultimately contain all human rights documents collected by the Human Rights Internet (HRI) since 1980.

**International Law in Domestic Courts** is a case reporting repository of domestic cases in international law from over 60 jurisdictions.

The **Rocky Mountain Mineral Law Foundation Digital Library** provides electronic access to articles and institute materials since 1955. See a librarian for log in information.
