## **Current Extension and Applied Research Projects**

Economic Impact of Agriculture and Natural Resources to Wyoming.

The goals of the study are a tripartite analysis of the natural resource base including agriculture, on the economy of Wyoming and counties. The study has three parts as outlined below:

- 1. Estimate jobs and income impacts of agriculture and natural resources. (Under Review)
- 2. Estimate the cost of community services in these local resource based economies and the impact and risks associated with local government public finance and the provision of essential public services
- 3. Estimate economic impacts of innovation and entrepreneurship in the agriculture sector

Increase Weather and Climate Awareness, Preparedness, and Responses in Wyoming Rural Agricultural Communities

Agricultural producers need timely, science-based, and region-specific information and technologies to enable them to make climate-informed decisions about their operations. This is especially true in Wyoming, where high-elevation rangeland and cropping systems and a semi- arid climate place producers and their communities at significant exposure to weather and climate variability. This project will enhance the climate resilience of rural, agricultural communities in Wyoming by increasing the weather and climate capacity of Extension professionals and other local Technical Service Providers (TSPs) who serve Wyoming agricultural communities. This goal will be accomplished through the following objectives:

- 1. Create the community, knowledge exchange, and resources needed to build weather and climate literacy among Extension professionals and other TSPs.
- 2. Identify, adapt, and make accessible tools and infographics that translate raw weather and climate data into user-friendly and actionable information relevant to decision-making in the project state's agricultural systems and climate conditions.
- 3. Create Extension products and outputs that translate existing research into user-friendly and accessible outputs/materials that can assist with weather and climate decision-making.

Land Grant-Tribal Partners Thriving Communities Technical Assistance Center for Region 8 . Collaboration between Montana State University (lead), Colorado State University, and University of Wyoming

TCTAC's primary objective is to deliver effective, locally informed technical assistance to increase the capacity of entities committed to energy and environmental justice in Region 8 to successfully identify, apply for, win and manage grants; secure private funding; and build coalitions to amplify their collective power. Outreach will be focused on underserved and overburdened communities throughout the region's six states and 28 Tribes so they can access in-person and virtual training and technical assistance to build critical capacity and generate funding to successfully implement their projects.

Bader Thapa R., R. Coupal. 2019 continuing. Coal Char / Biochar economic and lifecycle analysis. The study is a collaboration with the University of Wyoming's School of Energy Resources to look for alternative uses of coal. This project looks at the pyrolysis of coal and plant residue to create a char as a one time application of a soil additive to both poor soils and high quality soils. The study will assess the following for comparisons:

- 1. Cost and net present value of using coal char and biochar.
- 2. Growth in usable usable carbon in the soil from the cation exchange characteristics of the chars
- 3. Complete carbon lifecycle analysis of the two types of char.

Haggerty, J., M. Haggerty, M. Eggars, R. Coupal. Indigenizing Fiscal Policy for Just Transitions

This is an integrated research program and engagement with the Apsáalooke (Crow Nation) in Montana. It seeks to identify the policy reforms, governance processes, and investments in local capacity necessary to reverse the trajectory whereby a low-carbon energy transition in the U.S. amplifies social vulnerability in resource peripheries. The objectives are as follows:

- 1. How does fiscal policy (public revenue collection and spending) interact with economic vulnerability in the context of a reservation economy experiencing the effects of the energy transition?
- 2. How do historical decisions influence local capacity to sustain public services in the context of declining revenues?
- 3. Under existing policy frameworks, what is the potential for low carbon energy development projects to sustain critical public services?
- 4. As current and future leaders assimilate and share the knowledge and skills involved in addressing fiscal policy and its implications and anticipating the need to evaluate proposals for future energy and natural resource development, what would it mean to indigenize fiscal policy?
