Title: ASUW Budget: Fiscal Year 2009

1. WHEREAS, the mission of the Associated Students of the University of Wyoming
2. (ASUW) is to serve its fellow students in the best manner possible through accurate
3. representation, professional interaction with campus programs and organizations, and
4. responsible, effective leadership; and
5. WHEREAS, ASUW collects a student fee to administer the programs and services of
6. ASUW, to fund the governing boards of the ASUW Student Government, and to support
7. Recognized Student Organizations; and
8. WHEREAS, Senate Bill #2197 was passed to allocate \$17,025 out of the ASUW Reserve
9. for the Collegiate Readership Program; and
10. WHEREAS, ASUW supports funding the ASUW Student Legal Services Clinic (SLSC)
11. through FY '09 and will cease funding at the completion of FY '09; and
12. WHEREAS, the cessation in future funding has been communicated to the dean of the
13. College of Law and the director of SLSC.
14. THEREFORE, be it enacted by the Associated Students of the University of Wyoming
15. (ASUW) Student Senate that the budget of ASUW, its contingencies, and all part thereof
16. for Fiscal Year 2009 be approved as allocated from the following sources: \$836,044 from
17. the ASUW Fees; \$89,867 from the ASUW Reserve; \$37,925 from the ASUW Equipment
18. Reserve; \$45,000 from the ASUW Special Projects Endowment; \$36,000 from the

19. ASUW Scholarship Endowment; \$820 from the ASUW Student Loan Account and
20. \$77,370 from other revenues; and
21. THEREFORE, be it further enacted that the total budget for Fiscal Year 2009 shall be
22. \$1,123,026 as allocated in Addendum A; and
23. THEREFORE, be it further enacted that Fiscal Year 2009 be the last year that the ASUW
24. allocate funding to the Student Legal Services Clinic; and
25. THEREFORE, be it further enacted that the logistics of administering this budget, which
26. utilizes funds from the ASUW Fees, the ASUW Reserve, the ASUW Equipment
27. Reserve, the ASUW Special Projects Endowment, the ASUW Scholarship Endowment,
28. the ASUW Student Loan Account and other revenue accounts be under the direction of
29. the ASUW Business Manager.

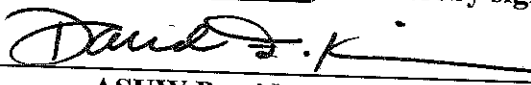
