

SENATE BILL #1547, AMENDED

Title: Sports Club Transfer

Introduced: January 13, 1987 (amended April 28, 1987)

Thesis:

Sponsor: ASUW Sports Club Committee

1. Whereas the Sports Club Program, which is a financially supported program
2. of the Associated Students of the University of Wyoming, has been denied
3. additional funding until the problems that stem from mismanagement be
4. solved, be it enacted by the Student Senate of the Associated Students of
5. the University of Wyoming that the Student Senate transfer the
6. administration of the program to the Intramural Department which has the
7. facilities and capabilities to manage such a program effectively and to
8. show support for a worthy program. The Student Senate will also agree to
9. transfer a line cut amounting to a total of no less than \$10,782 annually
10. from the student fees, with \$6,000 to be set aside specifically designated
11. as salary for a professional sports club director, to go directly to the
12. Intramural Department for management and upgrading of the program and the
13. remainder going for operational expense. This transfer is contingent upon
14. acceptance by the Intramural Department. If the Intramural Department
15. decides not to accept this transfer, the Sports Club will cease to exist
16. for the 1987-88 fiscal year and \$10,782 will revert back to ASUW. ASUW
17. will also appoint a senator to serve regularly on the Sports Club Council,
18. who will act as a liaison between the Senate and ASUW. The representative
19. for the Sports Club Council will be responsible for representing the club

- 20. in Finance Budget and Planning where the Sports Club's budget will be
- 21. reviewed no less than biannually.
