

SENATE BILL #1792

Title: Ex-officio Criteria

Date: March 2, 1995

1 WHEREAS, there is a large ~~population~~ *number* of student
2 ~~organizations~~ *groups* on campus; and

3 WHEREAS, the ASUW Student Senate foresees a greater number
4 of student ~~organizations~~ *groups* seeking ex-officio positions
5 on the ASUW Student Senate; and

6 WHEREAS, the ASUW Student Senate believes that ex-officios
7 should promote an awareness of diversity on campus, enhance
8 student involvement in the University community, and create
9 an environment of cooperation and association outside of the
10 classroom;

11 THEREFORE, be it enacted by the Student Senate of the
12 Associated Students of the University of Wyoming that any
13 new student organization seeking an ex-officio position must
14 have that position approved by the Constitution Committee
15 and further approved by the ASUW Student Senate; and

16 THEREFORE, be it further enacted that Article 2, Section 6,
17 Subsection B *of the ASUW By-Laws* read:

18 "B. All student organizations seeking an ex-officio
19 position on the ASUW Student Senate must have that
20 position approved by the Constitution Committee and
21 further approved by the ASUW Student Senate. Student
22 organizations seeking an ex-officio position must

exhibit all of the following criteria:

1. The organization must provide a diverse array of co-curricular activities including cultural, international, athletic, and/or student life programs.

2. The organization must utilize informal educational opportunities which promote growth and involvement enriching daily life.

3. The organization must promote an environment of excellence and achievement in an atmosphere that allows for inquiry and expression.

4. The organization must provide opportunities for credit/non-credit instruction, lifelong learning, and/or professional and cultural programming.

5. The organization must be inclusive ~~for~~ of the general campus population.

6. The organization's services must be used by a diverse segment of the campus population.

7. The organization must be a recognized student organization."; and

43 THEREFORE, be it further enacted that Article 2, Section 6,
44 Subsection B *of the ASUW By-Laws* be amended to Subsection C;
45 and
46 THEREFORE, be it further enacted that the existing ex-
47 officio positions currently held are exempt ~~for~~ *from* the
48 above criteria. ~~and that the ex-officio positions of Inter-~~
49 ~~Fraternity Council and Panhellenic Council be held by~~
50 ~~existing Greek senators if adequate.~~
