

SENATE BILL #1812

Title: Finance Appropriations Request Increase  
Date: January 31, 1996  
Authors: Budget and Planning Committee

1 WHEREAS, the purpose of the Finance Appropriations Committee  
2 is to provide funding for unanticipated programming and  
3 registration expenses; and  
4 WHEREAS, expenditures by the Finance Appropriations  
5 Committee are currently limited to \$500 for programming and  
6 registration by the ASUW Finance Policy; and  
7 WHEREAS, for the past two consecutive fiscal years,  
8 unanticipated requests for funding averaging between \$1,000  
9 and \$4,000 have arisen; and  
10 WHEREAS, these requests, being over the \$500 expenditure  
11 limit for the Finance Appropriations Committee, have been  
12 sent to the Budget and Planning Committee for consideration;  
13 and  
14 WHEREAS, funding for these requests has been taken out of  
15 the reserve through the legislative process with the  
16 approval of the University of Wyoming Board of Trustees;  
17 THEREFORE, be it enacted by the Associated Students of the  
18 University of Wyoming that Section II, Subsection K of the  
19 ASUW Finance Policy be amended to read as follows:  
20 "All interim year requests by Recognized Student  
21 Organizations or University departments or divisions for

22 additional funding up to \$3,000 for activities and programs  
23 or \$500 for registration fees be made through the ASUW  
24 Finance Appropriations Committee."; and  
25 THEREFORE, be it further enacted that Section IV, Subsection  
26 A, Line 1 of the ASUW Finance Policy be amended to read as  
27 follows:

28 "Student organizations or University departments or  
29 divisions may seek funding for up to \$3,000 for activities  
30 and programs or \$500 for registration fees by making  
31 application requests for activities and programs or  
32 registration monies to the Finance Appropriations  
33 Committee."; and

34 THEREFORE, be it further enacted that Section V, Subsection  
35 A of the ASUW Finance Policy be amended to read as follows:

36 "A University Recognized Student Organization, ASUW  
37 Entity, or University departments or divisions seeking more  
38 than \$3,000 for activities and programs or \$500 for  
39 registration fees must receive ASUW government sponsorship  
40 through the ASUW legislative process."
