

**SENATE BILL #1834**

**Title: ASUW Library Fee**

**Date: November 12, 1996**

**Authors: Budget & Planning Committee**

**Sponsors: Senators Anthes, Curry, Donelan, Plemmons, Wilson and Young**

1 WHEREAS, funding for the University of Wyoming library system has remained flat;  
2 and

3 WHEREAS, 4,677 scholarly journal subscriptions have been cancelled since 1987, at a  
4 value of \$965,677.00; and

5 WHEREAS, the need for current periodicals for instruction and research is ever  
6 increasing; and

7 WHEREAS, the availability of these journals on campus is decreasing due to lack of  
8 funding; and

9 WHEREAS, students are becoming frustrated with the inability of the library to  
10 provide adequate sources of information; and

11 WHEREAS, the ASUW Student Loan account is a regenerating account that has  
12 accumulated to nearly \$2.5 million over 30 years; and

13 WHEREAS, this account gains interest yearly and does not need as much student  
14 support as when it was created.

15 THEREFORE, be it enacted by the Student Senate of the Associated Students of the  
16 University of Wyoming, that the ASUW Student Loan Fee be decreased from \$2.50 to

1 \$1.00, and that \$1.50 of the ASUW Student Loan Fee will be reallocated to an ASUW  
2 ~~Library Fee, effective FY98, and~~  
3 THEREFORE, be it further enacted that during fiscal year 1998, the ASUW Library  
4 Fee will be used for the purchase of one copy machine and additional periodicals; and  
5 THEREFORE, be it further enacted that in years following fiscal year 1998, an  
6 advisory board consisting of 3 students (who shall be appointed by the ASUW  
7 President), 1 faculty, 1 staff and the Director of the Library Services will be formed  
8 to evaluate need and use of such fees and to allocate the fee monies annually.
