1. WHEREAS, the RSO Funding Board was created to better serve RSO funding
2. needs; and
3. WHEREAS, ASUW is an important funding source for RSO's; and
4. WHEREAS, the RSO Funding Board has limited resources to be used by over
5. 200 RSO's; and
6. WHEREAS, the RSO Funding Board has identified areas of the Finance
7. Policy that need revised to give the RSO Funding Board more effective guide-
8. lines to follow.
9. THEREFORE, be it enacted by the Student Senate of the Associated Students
10. of the University of Wyoming (ASUW) that the ASUW Finance Policy be
11. revised as outlined in Addendum A and that sections and subsections of the
12. ASUW Finance Policy be renumbered appropriately; and
13. THEREFORE, be it further enacted that these revisions to the ASUW Finance
14. Policy shall take affect January 1, 2007.

Addendum A

Proposed Revisions to the ASUW Finance Policy

Current	New
	<u>Section III. A. 8 a</u> Any videos purchased through ASUW becomes the property of ASUW, and must be returned to ASUW immediately following the event.
	<u>Section III. A. 8 b</u> Videos purchased through ASUW will be donated to Coe Library for student checkout.
<u>Section III. C. 3</u> A program evaluation must be completed in the Campus Activity Center.	<u>Section III. C. 3</u> A program evaluation must be completed by the RSO and turned in to the ASUW Director of Finance within 30 days following the event. Failure to complete the program evaluation may affect the RSO's future RSO Funding Board requests.
	<u>Section IV. A. 1 a</u> For events sponsored by multiple RSOs a single request must be submitted to the RSO Funding Board.
	<u>Section IV. A. 1 b</u> RSOs may only receive funding from one ASUW funding source per event, such as the RSO Funding Board, Student Activities Council, and Concert and Convocations. Exceptions to this policy may be considered by the RSO Funding Board and must be sent to the ASUW Senate for final approval.

	<p><u>Section IV. C. 1 a</u> Conferences/competitions occurring between July 1<sup>st</sup> and December 31<sup>st</sup> shall be defined as occurring in the fall semester.</p>
	<p><u>Section IV. C. 1 b</u> Conferences/competitions occurring between January 1<sup>st</sup> and June 30<sup>th</sup> shall be defined as occurring in the spring semester</p>
<p><u>Section IV. C. 1 a</u> For conferences occurring on or before June 30 of the current fiscal year, applications must be submitted at least 30 days prior to the end of the spring semester.</p>	<p><u>Section IV. C. 1 c</u> For conferences/competitions occurring on or before June 30<sup>th</sup> of the current fiscal year, applications must be submitted at least 30 days prior to the end of the spring semester.</p>
<p><u>Section IV. C. 1 b</u> For events occurring after July 1 and before the first day of classes of the current fiscal year, applications must be submitted within the first 30 days of the fall semester.</p>	<p><u>Section IV. C. 1 d</u> For conferences/competitions occurring after July 1<sup>st</sup> and before the first day of classes of the current fiscal year, applications must be submitted within the first 30 days of the fall semester.</p>
<p><u>Section IV. C. 2</u> Only students who are members of the ASUW are eligible to receive registration fees.</p>	<p><u>Section IV. C. 2</u> Only students who are members of ASUW are eligible to receive monies for registration fees. Registration fees will be paid by the ASUW Business Office.</p>
<p><u>Section IV. C. 3</u> The RSO Funding Board shall provide registration monies not exceeding \$500 per RSO for the same conference in the same fiscal year. Registration fees will be paid by the ASUW Business Office prior to the conference.</p>	<p><u>Section IV. C. 3</u> The RSO Funding Board may provide conference registration monies not exceeding \$500 per RSO per semester.</p>
	<p><u>Section IV. C. 4</u> The RSO Funding Board may provide regional and/or national competition registration monies not exceeding \$500 per RSO per semester. Exceptions to this policy may be considered by the RSO Funding Board and must be sent to the ASUW Senate for final approval.</p>
<p><u>Section IV. C. 4</u> ASUW funds allocated through the RSO Funding Board cannot be applied to travel, lodging, meals, or any other travel expenses associated with a conference.</p>	<p><u>Section IV. C. 5</u> ASUW funds allocated through the RSO Funding Board cannot be applied to travel, lodging, meals, or any other travel expenses associated with a conference/competition.</p>
<p><u>Section IV. C. 5</u> All registration documentation must be submitted to the ASUW Business Office within 30 days of the conference or the allocation shall be void and the funds shall be revoked.</p>	<p><u>Section IV. C. 6</u> All registration documentation must be submitted to the ASUW Business Office within 30 days of the conference/competition or the allocation shall be void and the funds shall be revoked.</p>
