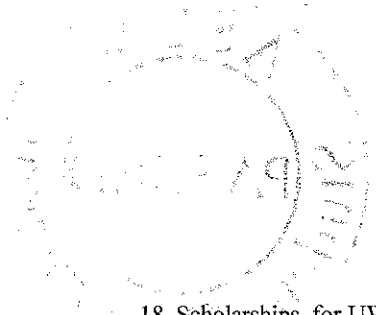


SENATE BILL #2329

Title: ASUW Scholarship Reform 2011

Sponsors: Senators Chenchar, Defebaugh, Drumhiller and Unangst

1. WHEREAS, over the past decade the Student Government of the Associated Students of the
2. University of Wyoming (ASUW) has established and provided the Charlotte Hearne Davis,
3. James C. Hurst, and ASUW Leadership Scholarships (Senate Bills 1960, 1961 and 2041
4. respectively) to University of Wyoming (UW) students in recognition of leadership, service,
5. and other extracurricular involvements; and,
6. WHEREAS, past legislation and current documents concerning the management and
7. administration of said scholarships are out of date and require revision to accurately
8. represent the intent of the ASUW in its mission to recognize UW students through
9. multiple scholarships; and,
10. WHEREAS, said revision will allow the ASUW to appropriately oversee and provide said
11. scholarships and reward the most deserving UW students.
12. THEREFORE, be it enacted by the Student Senate of the Associated Students of the
13. University of Wyoming (ASUW) that the scholarship guidelines for the Charlotte Hearne
14. Davis Scholarship reflect the contents of Addendum A; and,
15. THEREFORE, be it further enacted that the scholarship guidelines for the James C. Hurst
16. Scholarship reflect the contents of Addendum B; and,
17. THEREFORE, be it further enacted that the scholarship guidelines for the ASUW Leadership



- 18. Scholarships, for UW and high school students, reflect the contents of Addendums C and D,
- 19. respectfully; and,
- 20. THEREFORE, be it further enacted that Section V, subsection B of the ASUW Finance Policy

Three finalists from the pool of applicants will be chosen and given a personal interview by the Committee. The interview will be comprised of questions chosen annually by the committee. The interview process will be used, in part, to select the final recipient of the scholarship. The Charlotte Hearne Davis Scholarship shall be awarded for one-time use during the recipient’s sophomore (“sophomore” defined as the academic year immediately following the semester that the recipient accrues a minimum of 30 credits. Specifically, the academic year following participation in Freshman Senate) year. At its discretion, The Committee shall strive to award multiple scholarships (as the funds allow), dividing the annual interest income from the fund among two or more recipients. If deemed appropriate, the Committee may award all of the annual income from the fund to one scholarship recipient or may divide it among two or more recipients. If, in the judgment of the Committee, there is no eligible scholarship applicant during a particular year, the income from the fund may accumulate for the use in making awards subsequent years or may be used to augment the corpus of the fund. An additional \$3,000 shall be allocated for use as the payment of the Charlotte Hearne Davis Scholarship in 2001-2002 academic year to be distributed evenly between the fall semester 2001, and the spring semester.~~

~~2. The TRUSTEE is authorized to accept for administration, additional gifts and/or bequests to this fund from the UNDERSIGNED or others.~~

~~3. While the UNDERSIGNED intends that for the foreseeable future the income from the trust shall be used exclusively for the purposes and the manner set forth in Paragraph (1) above, the UNDERSIGNED recognizes the possibility of changes in the field of higher education that could eliminate, at some future time, the need for student scholarship support for the Minority Student Leadership Initiative Mentee program. Therefore, the UNDERSIGNED directs that should the TRUSTEE determine, after due consultation with the University of Wyoming President, that such is the case then the net income from the trust estate should be used for such useful educational purposes as the TRUSTEE may determine to be most closely related to the purpose set forth in Paragraph (1) above.~~

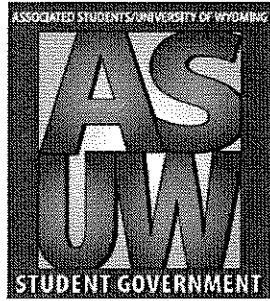

The TRUSTEE may do so without limiting the generality of the foregoing any may:~~
- ~~a. Invest and reinvest such trust corpus according to the Investment Policy accepted and approved by the University of Wyoming Foundation Board of Directors;~~
 - ~~b. Pool the subject matter of various gifts, bequests and devises into one or more funds for the purpose of investment and management;~~
 - ~~c. Employ the services of investment counselors, brokers, custodial banks and others carrying out the foregoing provisions, and to extract a reasonable fee for these services as determines solely by the TRUSTEE.~~

~~In no way should the use of the fund for the purposes set forth in Paragraph (1) above be prejudice. Gains and losses upon sales of corpus, share dividends and other distributions on corporate shares shall be allocated between principal and income in such a manner as the TRUSTEE may from time to time determine. The TRUSTEE shall have full power to vote and execute proxies to vote corporate shares included in trust corpus.~~

~~The foundation shall supply an annual accounting of the fund to ASUW Student Government and shall provide a copy of such accounting to the University of Wyoming Vice President for Administration and finance.~~

All members of the Committee (with the exception of the Dean of Students Office designee) shall be selected by the ASUW President. The scholarship award recipient will be chosen by a committee comprised of the chair of the Student Government Committee dealing with Student Relations, a designee from the Office of Student Life, the Student Government President, one Freshman Senate student advisor, and the Student Government Advisor. The above outlined Committee will choose the award recipient during the spring semester of each year.

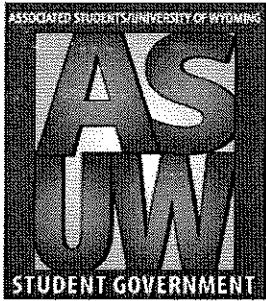

ADDENDUM E

ASUW LEADERSHIP SCHOLARSHIP ENDOWMENT

The undersigned, Associated Students of the University of Wyoming (ASUW) Student Government, hereinafter called the DONOR, having pledged the University of Wyoming Foundation, a non-profit corporation under the laws of the State of Wyoming, hereinafter called the TRUSTEE, the sum of \$250,000.00 for the uses and purposes and upon terms and conditions hereinafter set forth:

1. The trust hereby created shall be known as the ASUW Leadership Scholarship Fund and the above named TRUSTEE shall maintain the corpus thereof as a permanent fund. The net income only shall be used to make scholarship grants to fee-paying students enrolled in the net University of Wyoming. To be eligible for this scholarship, applicants must also:
 - a. Be a current year graduating high school student planning to enroll at UW, and/or a current student at the University of Wyoming
 - b. Demonstrate leadership participation in athletics, student organizations, student government, community service, athletics and/or other student leadership involvement
 - c. Have a high school cumulative GPA of 3.5 for graduating high school students or a cumulative UW GPA of 3.0 for UW students.

The recipients shall be judged, in part by the qualities he/she provides in a written resume of campus/high school and community involvement, awards, employment, etc. The recipients shall also be judged, in part, by a letter of reference and a 500 to 750 word single spaced one page essay written on a topic, chosen by the ASUW President and committee chair, pertinent to past, current and/or future leadership describing such past involvement and intended future involvement at UW/high school. Selection shall be made in accordance with Student Financial Aid procedure summer prior to attendance at UW. Scholarship recipients may be awarded the scholarship multiple times may be renewed each year by continuing UW students upon completion of the application process and maintenance of scholarship requirements. Student members of the Selection Committee shall not be eligible to receive the ASUW Leadership Scholarship.

Applications for scholarships shall be on such forms and in keeping with such procedures as are normally prescribed for applications for scholarships at the University of Wyoming.

The Committee shall strive to award multiple scholarships (as the fund allows), dividing the annual interest income from the fund among two or more recipients. If deemed appropriate, the Committee may award all of the annual income from the fund to one scholarship recipient or may divide it among two or more recipients. If, in the judgment of the Committee, there is no eligible scholarship applicant during a particular year, the income from the fund may accumulate for use in making awards in subsequent years or may be used to augment the corpus of the fund.~~

While the DONOR intends that for the foreseeable future the income from the trust shall be used exclusively for the purposes and in the manner set forth in pParagraph (1) above, the DONOR recognizes the possibility of changes in the field of higher education that could eliminate, at some future time, the need for scholarship support for the ASUW Leadership Scholarships. Therefore, the DONOR directs that should the TRUSTEE determine, after due consultation with the University of Wyoming, that such is the case then the net income from the trust estate should be used for such useful educational purposes as the TRUSTEE, in consultation with ASUW and the University, may determine to be most closely related to the purposes set forth in pParagraph (1) above.~~

~~6. It is intended that ASUW Leadership Scholarship Fund shall be a competent part of UW Foundation and not a separate trust, and that nothing in this Agreement shall affect the status of the UW Foundation as an organization described in section 501-(c)(3) of the Internal Revenue Code and as an organization which is not a private foundation within meaning of section 509(a) of the Internal Revenue Code. This Agreement shall be interpreted in a manner consistent with foregoing intention and so as to conform to the requirements of such provisions of the federal tax laws and any regulations pursuant thereto. 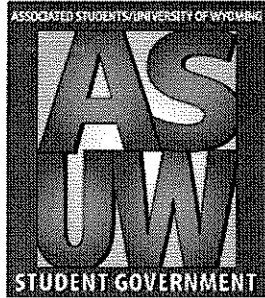

~~In no way should the use of the fund for the purposes set forth in Paragraph (1) above be prejudice. Gains and losses upon sales of corpus, share dividends and other distributions on corporate shares shall be allocated between principal and income in such a manner as the TRUSTEE may from time to time determine. The TRUSTEE shall have full power to vote and execute proxies to vote corporate shares included in trust corpus.~~

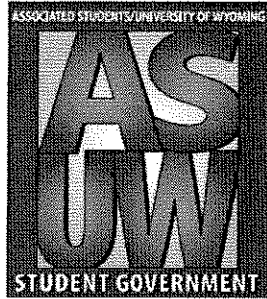
