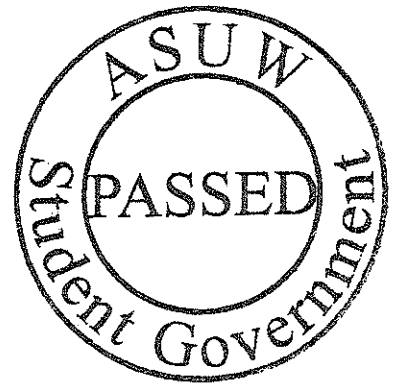

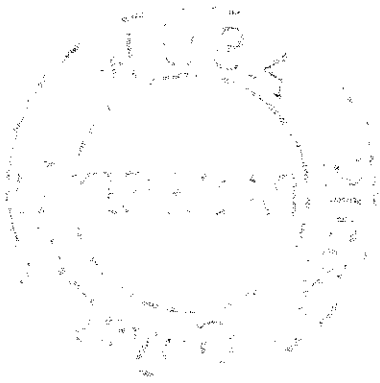
SPONSORS: Senators Hasley, Igo, Kolf, Messer, Rawlings, and Unangst

1. WHEREAS, The Student Government of the Associated Students of the University of
2. Wyoming (ASUW) includes a Freshman Senator in the composition of each of the standing
3. committees except for the Steering Committee, and;
4. WHEREAS, The Freshman Senate receives and debates each piece of legislation that is
5. brought before the ASUW Senate.
6. THEREFORE, be it enacted by the Student Government of the Associated Students of the
7. University of Wyoming (ASUW) that Article II, Section 10, Subsection A, Clause vi of the
8. ASUW Bylaws be amended to reflect the changes contained in Addendum A.

## Addendum A

### ARTICLE II Legislative Branch

#### Section 10. Senate Committees:

##### A.

- vi. The ASUW Steering Committee:
  - a. Purpose. The Committee shall provide coordination for the various issues, legislative activities, and program involvements of the ASUW Executive and Legislative branches, and serve to pursue ASUW recommendations and actions that are referred to, or require action by the University Trustees, the faculty, or administrative units of the University. The Committee shall also organize an informational meeting for Senators serving their first term in office before the first meeting of the new senate.
  - b. Powers. The Committee shall refer proposed ASUW legislation to ASUW standing or special committees for specified action or recommendation prior to final consideration by the Senate. Further, the Committee may recommend the procedure for implementing consideration of ASUW decisions, actions, or legislation after final action by the Senate, and the committee shall provide regular reports to the Senate on the status or final outcome of all matters that require action by officials outside of the ASUW. The committee shall have the power to call Senators before its membership to discuss alleged violations of the ASUW Rules and Procedures, Article III, Section 1 – Absent Voting Members, ~~as well as compliance with the senator handbook.~~
  - c. Composition. The Committee shall consist of the ASUW Vice President, who shall serve as chairperson, the ASUW President Pro Tempore, the ASUW Parliamentarian, the ASUW Sergeant at Arms, the ASUW Marshal, two (2) ASUW Senators, ~~one (1) Freshman Senator from the Freshman Senate Steering Committee.~~ the ASUW Advisor, and the ASUW Secretary.
