# **ASUW FRESHMAN SENATE MINUTES**

The April 3<sup>rd</sup>, 2018 meeting was called to order by Presiding Officer Sanders at 5:00 PM. Freshman Senators Schieffer and Talamantes were absent.

## **OPEN FORUM**

## **SPECIAL EVENT**

University of Wyoming President Dr. Laurie Nichols came to discuss the progress the university has made over the past year and what they are looking forward to in the future. Over the past year, the administration has been excited to work with students in the development of the university's Strategic Plan, with goals surrounding enrollment, retention, graduation rate, involvement, and opportunities for students. They worked to implement a standardized program fee to improve transparency surrounding student fees and include professional advising in every college across campus. The Public Art Initiative and Master Housing Plan were also approved over the past year. Looking to the future, President Nichols is excited about the Institute for Innovation and Entrepreneurship, which will allow students from any major to access classes that could help them build or expand a business in the future. It hopes to embed entrepreneurship minors into several colleges across campus, not just in the College of Business. With the university's budget in recovery, hiring efforts for the fall have begun. Consulting has been underway to determine the university's capacity growth and evaluate what levels tuition should be at. The university can facilitate over 1000 more students on campus without a need to drastically increase resources, so the possibility of lowering out of state tuition to draw more students is being considered. The new tuition level will be proposed to the Board of Trustees in September. The university is also working on a branding and marketing campaign which will hopefully draw in more students who are excited about the University of Wyoming.
