**TITLE:** ASUW Establishment of Rave Guardian Mobile Safety Ad-Hoc Committee and Support for the After-Hours Pedestrian Safety Ad-Hoc Committee Report

1. WHEREAS, the Mission of the Associated Students of the University of Wyoming
2. (ASUW) Student Government is “to serve its students in the best manner possible
3. through accurate representation, professional interaction with campus programs and
4. organizations, and responsible, effective, leadership;” and,
5. WHEREAS, the After-Hours Pedestrian Safety Ad-Hoc Committee focused its efforts on
6. the mobile application Rave Guardian and its implementation and maintenance for
7. University of Wyoming (UW) students both on the UW campus and beyond; and,
8. WHEREAS, the After Hours Pedestrian Safety Committee will dissolve at the end of the
9. 105<sup>th</sup> ASUW administration; and,
10. WHEREAS, a Memorandum of Understanding signed between the University of
11. Wyoming Police Department and the Division of Information Technology requires the
12. establishment of an ASUW operated Rave Guardian Ad-Hoc Advisory Committee in
13. order to continue the efforts of improving safety on, and around campus; and,
14. WHEREAS, the committee will be charged with the continual evaluation of the Rave
15. Guardian mobile safety application for the next three years;
16. THEREFORE, be it enacted by the ASUW Student Government that the Rave Guardian

17. Ad-Hoc Advisory Committee be established for the 106<sup>th</sup>, 107<sup>th</sup>, and 108<sup>th</sup>
18. Administrations of the ASUW Student Government under the guidelines outlined in
19. addendum A; and,
20. THEREFORE, be it further enacted that the Rave Guardian Ad-Hoc Advisory Committee
21. give a report at the end of the third contract year of the Rave Guardian Contract on the
22. continuation of the Rave Guardian Mobile Safety Application.

## Addendum A

### **Charge of the Rave Guardian Mobile Safety Ad-Hoc Committee**

The Rave Guardian Mobile Safety Ad-Hoc Committee will be charged with the continual evaluation of the Rave Guardian Mobile Safety Application. In addition, the committee will be charged with the marketing and developing guidelines for the mobile application and its operation. As outlined in the 2018 ASUW After-Hours Pedestrian Safety Report.

The Rave Guardian Mobile Safety Ad-Hoc Committee has its charge to:

- a. Provide a proof of concept report for the first three years which include:
  - i. Reviewing intelligent reporting data provided by UWPD and UWIT
- b. The marketing of the mobile application Rave Guardian:
  - i. Market Rave Guardian on multiple platforms including but not limited to: social media, posters, union tabling, stickers, and wearable promotional materials.
  - ii. Market with multiple partners including but not limited to: UW Athletics, UW Institutional Marketing, the Center for Student Leadership and Engagement, UW Admissions, A-Team, Laramie Downtown Alliance, Laramie Tavern Association, UW Residence Life and Dining, Local News Affiliates, UW No More Campaign, and UW Title IX Office.
- c. The ad-hoc committee, will also be required to hold a minimum of one marketing event per academic semester to encourage continual use and downloading of the Rave Guardian Mobile Safety Application. This event may include but is not limited to an extensive short-term social media campaign, raffles or giveaways

incentivizing downloads, presenting in First-Year Seminar (FYS) classes upon consent of instructors, and Union Tabling.

### **The Rave Guardian Mobile Safety Application Committee Composition**

The ASUW Rave Guardian Mobile Safety Application Ad-Hoc Committee will be comprised of members of the ASUW Student Government, Students at Large, as well as campus partners from across campus.

The composition of said committee is to include:

- A chairperson, who stands as a current student of the UW and shall be appointed for a two-year term appointed by the ASUW President.
- the current ASUW President
- two (2) current ASUW Senators
- two (2) Student's at Large
- one (1) ASUW Executive
- A representative from:
  - UW Police Department (UWPD)
  - UW Division of Student Affairs
  - UW Institutional Technology (UWIT)
  - the Equal Opportunity and Response Unit (EORR).

All committee members apart from campus partner representatives will be appointed by the ASUW President.

The President and Chief of Legislative Affairs will determine any additional or substituted representatives as needed.
