## **College of HS budget report**

HS students will be given priority to check out the devices the first 2 weeks of the semester. After the first 2 weeks the devices will be made available to the general student population. One of each device will be kept in reserve for shorter term checkout by HS students so they can have access to a device if their personal machine has to be repaired.
