**Wyoming Advisory Committee to the U.S. Commission on Civil Rights
Public Briefing: *Hate Crimes in Wyoming***

On November 1, 2019, in Casper, the Wyoming Advisory Committee to the U.S. Commission on Civil Rights will host a public briefing to gather testimony on hate crimes. Among related concerns, the Committee will receive testimony on the sufficiency of current equal protection laws in Wyoming, the prevalence of bias-related incidents, the prevalence of hate groups, and barriers that may prevent law enforcement from addressing bias-related crimes.

The Committee invites members of the public in attendance to share their comments and opinions during two open comment sessions, at 11:45 a.m. and 3:45 p.m. The Committee will also accept written comments submitted to afortes@usccr.gov by December 1, 2019. Following the meeting, the Committee will issue its findings and recommendations in a report to the Commission.

Dr. Robert Byrd, Chair of the Committee, stated: “The Advisory Committee presents to the citizens of Wyoming a unique opportunity to explore a gathering of information focused on the civil rights and concerns related to hate motivated incidents and crimes in our state. We as a committee want to fully explore and understand hate crimes in Wyoming. Then, perhaps, we as Wyomingites can consider a way to move forward that enables law enforcement, legislators, and state government officials to address these incidents, if any, which may exist in the State of Wyoming.”

The U.S. Commission on Civil Rights has frequently expressed concern about hate crimes and bias-motivated incidents across the nation. The Wyoming Advisory Committee joins a number of other state Committees in working to address – and stem - these heinous acts.
