Chair Laegreid called the Faculty Senate Executive Committee (FSE) meeting to order at 12:08 pm.

Resolution 429; *Resolution Regarding Minor in English as a Second Language Education*, was then opened for discussion.

The Chair then brought the Committee on Committees' Decision to the table. Discussion followed.

The Chair then opened a discussion on implications of Artificial Intelligence. Discussion followed.

The Faculty Senate Agenda was discussed.
