33	on page 16 under Human Culture and under STEM currently reading "Courses may not be		
34	counted toward the major" be replaced by "Courses may not be from within the major

37	<ul> <li>Recommends that language on page 16 under "Human Culture" and "STEM" that currently</li> </ul>		
38	reads "Departments will be given the opportunity to designate courses as HC, STEM or neither"		
39 40	be changed to read "Departments will be given the opportunity to designate courses as HC, STEM, neither, or some proportion of both (e.g., a 3-credit-hour interdisciplinary course that		
40 41	combines HC and STEM disciplines could be designated as 1 hour HC and 2 hours STEM, or 1.5
