This report describes Center for Global Studies (CGS) activities across 2016-17 academic year (July 1, 2016-June 30, 2017) in its third year of operation in its three primary areas of focus: 1) **faculty research opportunities**; 2) enhancement of graduate and undergraduate international education by establishing **international fieldwork, research, and internship opportunities**; and 3) **enhancing engagement by sponsoring speakers, and symposia on and off campus**.

Vision: Bringing the world to Wyoming and Wyoming to the world by fostering internationally oriented, interdisciplinary studies through research, in-depth learning, and community service.

Mission Statement: The Center for Global Studies brings a world of possibilities to UW and Wyoming. Focusing on evolving international challenges and their implications, whether across the globe or across the state, CGS supports student and faculty research in a variety of program areas. By providing access to funding and expertise, the Center's mission is to serve as a clearinghouse to enhance international competencies to prepare Wyoming students, communities, and businesses, to compete, engage and succeed in the global economy. Our statewide outreach programming demonstrates our commitment to sharing what we have learned.

Faculty Research Excellence and Outcomes

The Center for Global Studies will support nine new faculty research projects through its CGS Research Excellence Awards for international fieldwork in summer/fall 2017. These awards provide up to \$5,000 in seed money for international research. In the last three years, CGS has funded more than three dozen faculty projects from all of UW's colleges and schools. These funds are made possible through our partnership with the Office of Research and Economic Development, School of Energy Resources, the U.S. Senator Malcolm Wallop Fund for 'Conversations on Democracy' through the College of Arts and Sciences and the American Heritage Center, as well as donors who support the mission of the Center for Global Studies. **CGS awarded \$32,000 for Summer 2017 faculty projects (\$120,000 awarded over last three years).**

Expanding Student International Research and Internship Opportunities

The Center for Global Studies supported twenty new student research and internship projects through its CGS International Research/Internship Excellence Awards in Summer 2017 for students from the Colleges of Arts and Sciences, Agriculture and Natural Resources, Education, Business, Engineering and Applied Science, and the Haub School of Environment and Natural Resources. These awards provide up to \$2,500 for each student. CGS has funded more than five dozen student projects over the last three years. The Center awarded two graduate fellowships of \$10,000 each, and a \$5,000 undergraduate scholarship to cover tuition and college expenses for an undergraduate student studying international energy/natural resources. These awards are funded through private donations and through UW partnerships. **The Center provided \$46,000 to support student international research and internship projects (as compared to \$40,000 in 2016 and \$32,500 in 2015) and \$25,000 in graduate fellowships and student scholarship support.**

The Center supports two \$10,000 graduate fellowships. The **David and Jade Walsh Graduate Fellowship in Global Studies** is open to one outstanding graduate student completing a thesis or dissertation project focused on internationally oriented topics related to energy security and/or international security with consideration for projects also focusing on international aspects of environment and natural resources/development. The **Nielson Graduate Excellence Fellowship**, supported by the School of Energy Resources, is open to a graduate student completing a thesis or dissertation project focusing on internationally oriented topics related to energy and sustainability of natural resources and which addresses questions focused on solving critical challenges faced by society. At the undergraduate level, the Center supports the **SER Nielson Undergraduate Scholarship**, which covers in-state tuition for a student in his/her senior year.

Broadening the Impact of Outreach, Speakers, and Symposia at UW and Around Wyoming

The Center continues to support on-campus symposia/lectures and extensive statewide outreach activities with partners from across the state including Wyoming's community colleges. Through a combination of public and private funds, CGS offers a variety of lectures on campus and around Wyoming including a specific focus on sharing the faculty and student

research projects funded by CGS. In eight years, the statewide lecture series (in partnership with Global and Area Studies) has included around 200 sponsored events drawing more than 20,500 participants to a variety of formal and informal lectures.

1. CGS UW Presentations and Partnerships – 2016-17

Externally Funded Partnerships. The lecture series on **Germany Meets the US**, organized in cooperation with CGS (Dr. Stephanie Anderson) and by Dr. Tracey Owens Patton and Dr. Kristen Landreville from the Department of Communications, featured seven lectures/events across campus in Fall 2016. Funded by a grant from the German Embassy for the third year in a row, the series kicked off with Ambassador Peter Wittig of the Federal Republic of Germany to the United States. CGS organized the **International Relations in 2030 Workshop** in cooperation with the Free University of Berlin (Dr. Thomas Risse and Dr. Tanja Borzel) in August 2016, which brought prominent experts from across the globe to discuss trends in the field of international relations. The workshop included a public panel discussion on foreign policy and the 2016 elections. The visit of **Baroness Catherine Ashton, former EU High Representative for Common Foreign and Security Policy** was made possible by a partnership initiated by Dr. Stephanie Anderson with Denver University's Colorado European Union Center for Excellence and Women@IR in Washington, DC as well as UW's Department of Political Science and the Milward Simpson Fund in Political Science. Ashton gave a public address titled "A New World (Dis)Order," and a public talk on Women in Leadership.

Significant Internal Partnerships. The **Earth, Wind, and Water Series** (coordinated by CGS) was a collaboration with the International Education Steering Committee that involved all colleges and schools at UW to highlight the varied and important interdisciplinary work being done by UW faculty focusing on natural resources. CGS collaborated with various departments on campus to bring speakers to UW. Highlights of these partnerships include collaboration with the MBA program and International Programs to co-sponsor a roundtable for graduate students with **Colin Marshall, President and CEO of Cloud Peak Energy**. The visit of **Siphesihle Vilakazi**, a certified primary health care nurse who discussed her work with rural communities in South Africa on HIV/AIDS prevention, included partners such as Global and Area Studies, College of Health Sciences, School of Nursing, Milward L. Simpson Fund for Political Science, UW Honors Program, Department of English, Gender and Women's Studies Program and many community groups. The **CGS Faculty Brownbag Series** featuring Dr. Thorsten Janus (Department of Economics and Finance) discussing his research on "Economic Shocks and Political Transitions" was made possible by the Wallop Conversations on Democracy Program Fund housed within the College of Arts and Sciences and the American Heritage Center.

2. World to Wyoming Outreach and Global Studies Lecture Series – 2016-17

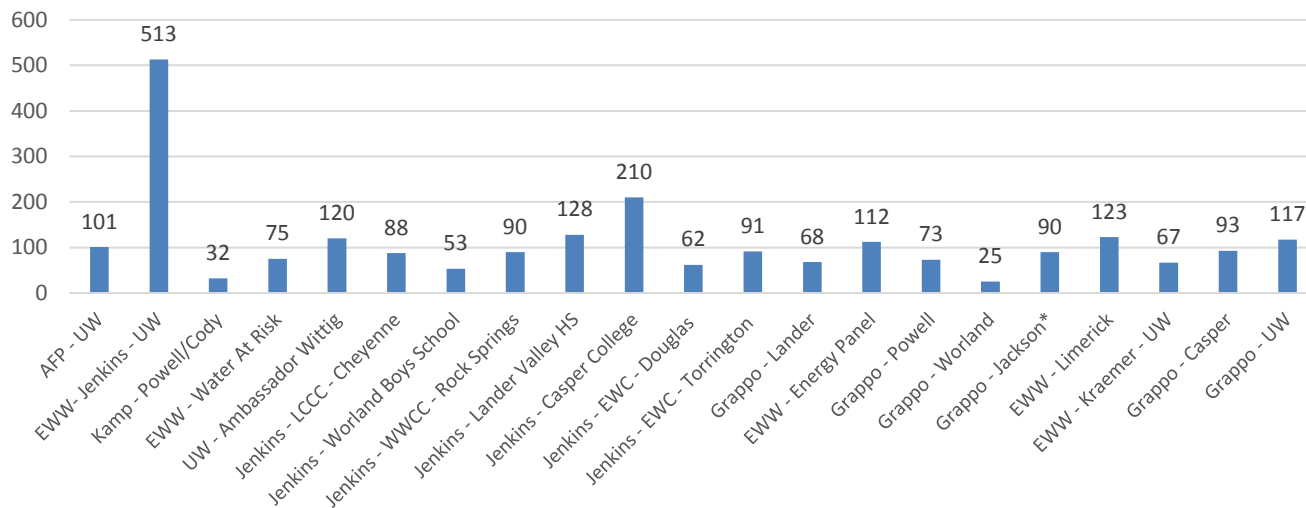
The Center for Global Studies (CGS) continues its commitment to significant on-campus and statewide outreach programming focusing on international affairs in communities around Wyoming and on the UW campus. This series has been made possible through partnerships with the Global and Area Studies Program, UW's Office of Academic Affairs and the Excellence in Higher Education Endowment, the UW Outreach School, the UW Foundation, International Programs Office, School of Energy Resources, and external partners including the Wyoming Humanities Council, Ruth R. Ellbogen Foundation, Homer A. and Mildred S. Scott Foundation, Rocky Mountain Power Foundation, InterConnections21 in Jackson, Wyoming's community colleges, the Free University of Berlin, and the Embassy of the Federal Republic of Germany.

Fall 2016 Global Studies Lecture Series Events

CGS sponsored/facilitated twenty-one events in eleven Wyoming communities in Fall 2016 – thirteen events around Wyoming and eight at UW. We started with a public lecture on American Foreign Policy and the 2016 Election and a workshop on International Relations in 2030 featuring prominent experts from Stanford, the Free University of Berlin, and UW. On campus, we organized a series of events across the whole fall semester under the theme **Earth, Wind, and Water Series** beginning with Mark Jenkins, UW writer-in-residence and *National Geographic* correspondent, who opened the series with his presentation, "Going to Extremes: Encounters with Earth, Wind, and Water." This was followed by panels on *Water at Risk* featuring an interdisciplinary group of UW experts, a panel on the energy transition with David Lawrence and Brad Nielsen (both formerly with Shell), and linked panels focusing on the Future of the West with Patty Limerick (University of Colorado-Boulder) and R. Andreas Kraemer (Founder & Director Emeritus Ecologic Institute, Berlin) discussing

Germany's Energy Transition. **World to Wyoming** presentations with Mark Jenkins on "Burma's Resurrection: An Expedition Deep into a Forbidden Land" continued at Laramie County Community College in Cheyenne, the Boys School in Worland, Western Wyoming Community College in Rock Springs, Lander Valley High School, Casper College, and Eastern Wyoming College campuses in Douglas and Torrington. UW Senior Visiting Scholar in Global Studies, Ambassador Gary Grappo (former US Ambassador to Oman), shared his expertise and experiences on "The Middle East and the Next US President" in six venues across Wyoming including Lander, Powell, Worland (in partnership with Rotary and Kiwanis), Jackson, Casper, and at UW. Other events included, Dr. Marianne Kamp (Dept. of History) who led discussions on the Middle East as part of the Wyoming Humanities Council bridge program in Powell and Cody. CGS hosted the German Ambassador to the United States, Dr. Peter Wittig, who presented "A World in Turmoil," focusing on the transatlantic partnership.

Global Studies Lecture Series Attendance – Fall 2016

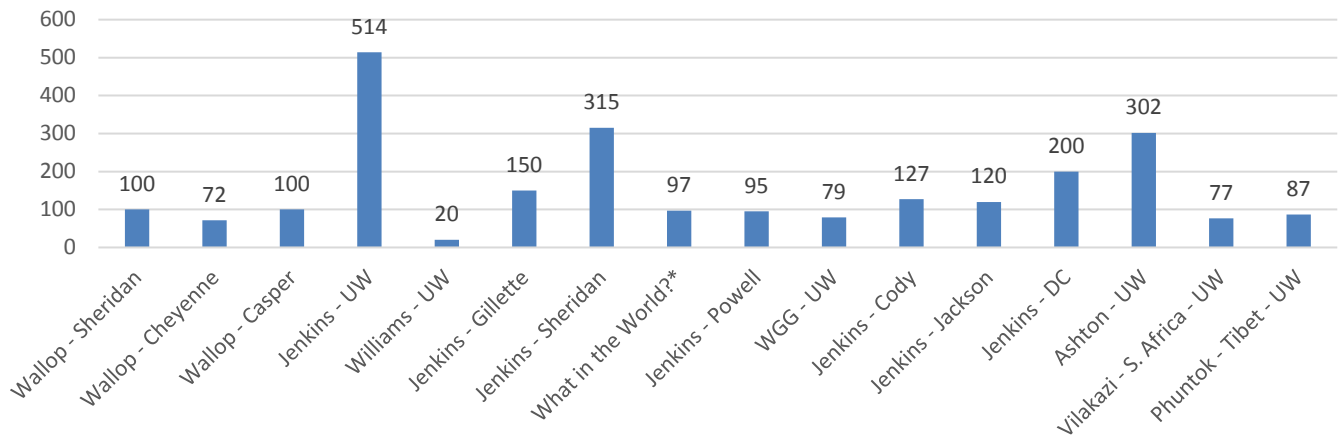

Spring 2017 Global Studies Lecture Series Events

CGS sponsored/facilitated eighteen events in ten Wyoming communities and Washington, DC across Spring 2017. In February, CGS launched a new series, **the US Senator Malcolm Wallop Conversations on Democracy Program**, pairing Ambassador Gary Grappo (UW Senior Visiting Scholar in Global Studies) giving presentations on the "Arab Spring and Democratization in the Middle East" with presentations by students who received Wallop Fellowships for their international fieldwork projects. In February and March, Mark Jenkins's **World to Wyoming** tour continued with presentations on "Tea, Trade and Tyranny: Tibet and China Over Time" at UW, Gillette College, Sheridan College, Northwest College in Powell, the Cody Theatre in Cody, and the National Wildlife Museum in Jackson. Throughout the Spring, CGS sponsored graduate students' presentations of their international research in the **What in the World? International Studies Fieldwork** program in Sheridan, Cody, Powell, Jackson, and Centennial. CGS organized **World to Wyoming in Washington, DC** with the UW Foundation and Alumni Association – a UW alumni and friend event in Washington, DC sponsored by Wyoming's congressional delegation with a program featuring President Laurie S. Nichols updating guests on UW and Mark Jenkins's presentation on Burma's Resurrection. At UW, programs included Dr. Andrew Williams from St. Andrews (Scotland) discussing his research on Charles de Gaulle and the third annual **Wyoming Goes Global: Globalization, Sustainability and Resource Use Over Time**, presentations/posters highlighting the exciting and significant international research being done by UW faculty and students. In April, as mentioned above in the partnership highlights, Baroness Catherine Ashton, former EU High Representative for Common Foreign and Security Policy, gave her public address titled "A New World (Dis)Order," Siphesihle Vilakazi, a certified primary health care nurse, discussed her work with rural communities in South Africa on HIV/AIDS prevention, and Tashi Phuntsok, Director of the Tibet Museum in Dharamsala, India, gave a public talk titled, "Tibet: The Story and Struggle of a Nation."

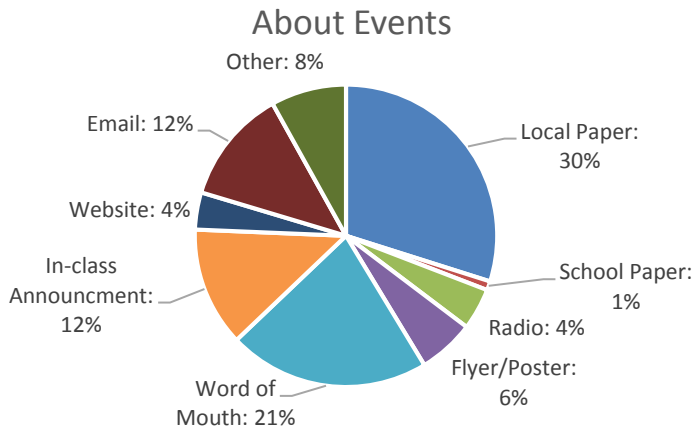
Global Studies Lecture Series Attendance – Spring 2017 Data



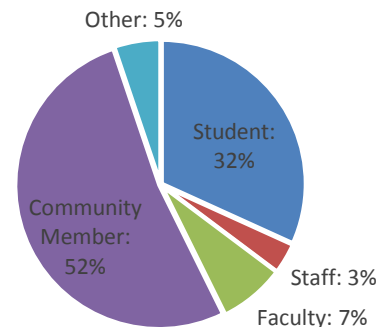

Number of attendants for these events = 2140 people; UW campus events = 1079 people; non-UW = 1061 people. Combined average attendance = 118 people/event.

The following charts display data gathered at speaker series events over the last year via short questionnaires distributed to audience members. Over 91% of respondents, which included students, faculty, staff, and community members, reported that the speaker series improved their understanding of global issues, and 94% stated that the event contributed to building a sense of international awareness.

Outreach Impact: How Attendees Learned

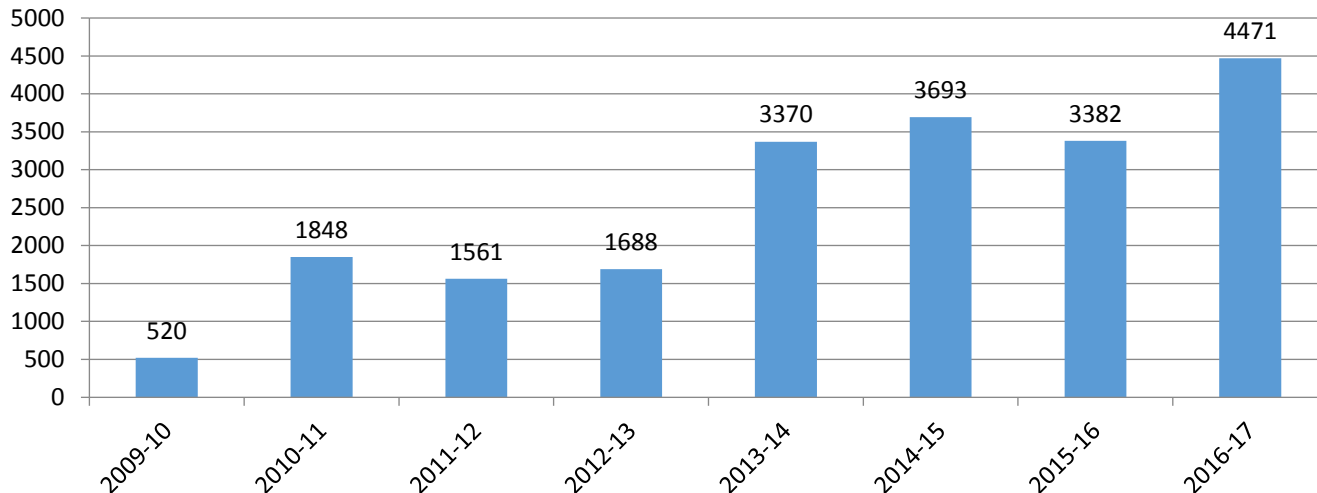


Audience Demographics

Partnerships and Sources of Funding – 2016-17

The Center for Global Studies has been able to establish these programs because of its partnerships with UW academic and administrative units and a growing list of external supporters. CGS raised over \$400,000 in private support through annual giving, endowments, and in-kind support for its programs in 2016-17.
