
# **Career Feature:**

# Trademark Law

My profession as a trademark attorney began two-and-a-half years after graduating from law school. After passing the bar exam, I began my lawyering career as a family law attorney helping clients with divorces and custody issues in addition to working as Guardian ad Litem representing abused and neglected children. Dealing with my clients' family heartbreak on a daily basis was not my cup of tea, and the work began to take a toll on my overall health and well-being. After realizing that my current career path wasn't right for me, I started investigating practice areas that would better fit my personality and life goals.

Trademark law immediately piqued my interest for the many kinds of flexibility it offers. Unlike most practice areas, your legal work is not confined within state lines. With one active bar membership, you can represent clients for federal trademark matters all over the United States. Furthermore, trademark prosecution (the legal process registering a trademark) can be done as a fully remote position. I do not require



a physical office, and all of my client meetings take place via Zoom or over the telephone. Lastly, I make my own schedule, do not have to appear in court, and don't have to deal with stringent litigation deadlines. While there are still some deadlines in trademark law, the time windows are bigger, and it is very rare to have an "urgent" trademark issue. With my current career in trademark law, I am the happiest that I've ever been as an attorney. I get to dedicate my efforts to helping businesses thrive and also have the time freedom that I need to pursue my other interests.

Quite frankly, being a lawyer is hard enough without trudging your way through a practice area that you don't enjoy. There are way too many resources and opportunities out there for attorneys to continue working unfulfilling careers. Below is some advice to help you find a practice area and/or legal career that you enjoy (based on my personal experience):

6 Tips to Find a Practice Area that Brings You Joy:

- Research. Get your Google on. You can find articles and resources about every practice area online. Also, check out the American Bar Association website for tons of articles and videos about different practice areas.
- Be a joiner. There are thousands of networking groups on Facebook and other social media platforms with lawyers and law professionals who are involved in the area of law you may be interested in. Join those groups and check out the members' posts. What kinds of challenges do they seem to be facing frequently? Do they enjoy what they do?
- Network. The dreaded "N" word the thought of talking to another human can be daunting. However, with today's technology and ability to network with people all over the world, there is zero excuse for not reaching out to other attorneys for help and insight. You will find that most attorneys are happy to provide valuable advice they were once in your shoes and know what it's like to struggle as a young lawyer.

- must accept that you will never know everything, and that is to be expected. Find a few trusted colleagues that you can reach out to for advice in your practice area as well as in practice management (ethics, billing, etc.) Don't forget about the wonderful Ethics Hotline offered by the Wyoming State Bar free of charge. Better safe than sorry when it comes to ethics questions, so don't be afraid to pick up the phone seriously.
- wracking when I accepted my first trademark case, but you will not learn your new niche unless you practice it. After all, this is called the *practice* of law. Remember to take your time and ask for help if you need it.

If you're sitting there thinking that this sounds like a lot of work, it's important to note that it's a lot harder to work a job you dislike. However, by utilizing some of the tips outlined above, you can hopefully find an area of law that brings you joy and satisfaction.



Delay discussing compensation for as long as possible. An employer becomes increasingly committed to hiring you.

Consider other elements of a job offer that may be equally valuable (i.e. bonus structure, floating holidays)

#### **Drawing a Line in the Sand**

Issuing an ultimatum is usually counterproductive and may cause negotiations to fall apart.
