# Career Highlight <<< >>> Transactional Law

Transactional law pertains to the legal transactions and communication essential in conducting business. Examples include commercial, healthcare, financial services, mergers and acquisitions, and real estate law. Each of the practice areas require excellent reading and writing abilities, negotiation skills, cultural competence, and solid comprehension of the fundamentals of contract law. Transactional attorneys must also understand the laws and regulations specific to their chosen practice area (i.e. data privacy in healthcare law). One of the ways to enhance these skills and abilities while in law school is through participation in the Estate Planning Practicum (EPP).

The EPP's transactional practice primarily focuses on Estate Planning and Estate Administration. The EPP provides law students an excellent opportunity to gain real and practical transactional experience in this field of law. The planning side of this practice primarily focuses on simple wills, advance health care directives, durable powers of attorney, as well as using other probate avoidance techniques, including, but not limited to, transfer on death deeds, beneficiary designations, payable on death designations, and transfer upon death designations. The administration side of the practice primarily focuses on summary procedures for estate administration available for qualifying estates in the State of Wyoming.

In addition to the summary procedures available to qualifying clients in the State of Wyoming, the EPP has recently begun to offer full probate and estate administration services to qualifying estates. These full estate administration services have significantly increased the workload borne by the students as well as exposing them to the complex nature of estate administration that encompasses a multitude of legal areas well beyond "estate law". Recently, students worked alongside the Faculty Director, Mario Rampulla, to manage the administration of these estates, with one being completed in 2022, and the other ongoing administrations are expected to be completed in 2024.

In addition to ongoing projects, the EPP has expanded by adding a 2L Legal Assistant to their staff, recognizing the importance of providing practical opportunities for students in their second year of law school. This addition not only enriches the educational experience but also mirrors the collaborative and team-oriented nature of transactional law practice.



The transactional law landscape requires professionals to possess a keen understanding of contracts, negotiations, and legal intricacies involved in legal dealings. By engaging in programs like the Estate Planning Practicum, students not only gain theoretical knowledge but also develop practical skills that are essential in advising clients. Aspiring transactional lawyers benefit from exposure to real-world scenarios and the chance to work alongside experienced practitioners, making them well-equipped to navigate the complexities of transactional law upon entering the legal profession.

It also serves as an informational portal for applicants and law schools to research judges and staff attorney offices hiring practices, preferences, and timelines.

# JOB INTERVIEW CHECKLIST

- >> Research your potential employer. Go beyond the organization's website.
- >> Know your resume and writing sample inside and out. Take extra copies of both to your interview.
- >> Prepare well-researched questions. Avoid questions that could have been easily addressed by reviewing the organization's website.
- >> Research yourself online.
  Employers are researching you as well.
- >> Come to the interview prepared. Dress appropriately; arrive 15 minutes early and have references prepared and confirmed.
- >> Ask Career Services if there are any alumni working at the firm and start networking.
- >> Participate in mock interviews.
- >> Understand the format and length of the interview.
- >> Be careful not to take branded items from other firms/organizations.
- >> Write a thank-you email that day and reference a key conversation point.
