The Wyoming Conservation Corps experience is extremely demanding both physically and mentally. Each year new members consistently underestimate the physical and mental requirements. **In addition to the physical demands of the projects, you should know that you will be sleeping and living outdoors much of the time in all weather conditions. Please consider the nature of the work prior to applying and let us know if you have any specific questions or concerns.**

Strenuous physical activity may include:

- Long days of shoveling, digging, and swinging heavy tools repetitively
- Heavy lifting; bending
- Hiking and carrying up to 60 pound backpacks at altitudes up to 12,000 ft.
- Working, eating, and living in the outdoors in all weather conditions
- Walking or working on steep or uneven terrain
- Working in extremes of heat or cold
