# Introduction

The Wyoming Survey & Analysis Center (WYSAC) at the University of Wyoming (UW) completed a survey of employees and students at the University of Wyoming to obtain feedback from the entire University community on how our institution handled the COVID-19 pandemic period in the course of the past two years. The survey was commissioned by the UW Enterprise Risk Management Advisory Committee (ERMAC). The findings are to help design actionable items for the immediate future and in similar crises situations that our institution may be faced with again.

The survey was conducted using the online mode of data collection.

<sup>1</sup> On Wednesday morning, February 16, the UW Board of Trustees voted to lift mask requirements in most indoor spaces, effective February 21. At the time of that announcement, 93% (n=1826) of surveys had been completed for this project. This should be considered when interpreting the results presented in this report.

# Methods

## *Questionnaire Development*

The survey instrument for this project was developed by WYSAC in collaboration with the UW Enterprise Risk Management Advisory Committee. The questionnaire was designed to capture all aspects of the policies, procedures and measures undertaken by the UW Administration in their efforts to mitigate the effects of the COVID-19 pandemic on the functioning of our institution, and obtain feedback from the entire University community on how timely, appropriate and successful these efforts have proven.

## *Mode of Contact and Mode of Data Collection*

Potential respondents were contacted by email and provided with a link to the online version of the survey and a unique access code.

## *Sampling Frame, Sample Design, and Sample Size*

WYSAC obtained contact information for all UW Laramie campus students and for all UW Laramie campus employees from the UW Registrar and from the UW Human Resources Department, respectively. All individuals contained in these lists were invited to take the survey.

## *Survey Administration*

After the survey instrument was finalized, it was programmed for online survey administration, and tested for programming errors. An initial survey invitation email was sent on February 8th, 2022, with reminder emails sent to those who had not completed the survey on February 11th and February 16th.

## *Response Rates*

A total of 1959 completed surveys were obtained. Of all surveys, 837 were completed by employees for a response rate of 31%, and 1122 surveys were completed by students for a response rate of 14%

## Data Compilation and Analysis

After data collection was closed, the data were exported into SPSS software and checked for consistency, including looking for any missing data and declaring missing values.

# Demographics

As can be seen from the table below, all major categories of UW employees are well represented in the final sample of respondents.

# Key Findings

Respondents were asked for their opinion on the timing, need and success of implementation of several measures introduced by the institution aimed at coping with the COVID-19 pandemic.

A majority of employee respondents believe that the timing of the face covering policy on campus (63%), the testing policy for COVID (67%), the work from home arrangements (67%), the remote classroom /teaching arrangements (53%) were “*on time*.” (See Tables 6, 7, 8, 9.)

Student respondents are less positive, but still close to 50% of those responding seem to believe that these measures were introduced *on time*. (See Tables 6, 7, 9.)

Among employees, similar are the results regarding the need for those measures. A majority of employee respondents believe that the face covering policy on campus (63%), the testing policy for COVID (64%), the work from home arrangements (61%), remote classroom/ teaching arrangement (62%), isolation or quarantining of students (66%) were *extremely necessary* measures. (See Tables 10, 11, 12, 13, 14.)

When considering students, in no case are those who think the measure was *extremely necessary* the majority. (See Tables 10, 11, 13, 14.)

Regarding the rate of success of the implementation of the aforementioned measures, employee respondents tend to believe that all of those measures were either *very successful*, or *somewhat successful* (69% re: face-covering policy; 70% re: testing policy; 76% re: work from home arrangements; 60% re: remote classroom/teaching arrangement; 52% re: isolation or quarantining of students). (See Tables 15, 16, 17, 18, 19.)

Again, students appear to be less convinced of the successful implementation of these measures. (See Tables 15, 16, 18, 19.)

The difference in satisfaction levels between teaching faculty and students with regard to how remote classroom/teaching was organized is significant. While 63% of faculty are either *very satisfied* or *somewhat satisfied*, only 33% of students express satisfaction. (See Table 20.)

Employees and students differ by a large margin in their overall satisfaction with how the institution handled the situation around the pandemic, with 50% of employees reporting to be



either *very satisfied* or *somewhat satisfied*, while only 29% of students appear to feel the same way. (See Table 22.)

Employees are much more satisfied with how their department handled the situation around the pandemic, with 73% reporting to be either *very satisfied* or *somewhat satisfied*. (See Table 23.)

Satisfaction with the vaccination campaign the institution undertook in spring 2021 stands at only 50% among employees and 31% among students. (See Table 24.)

Respondents were asked to reflect specifically on the testing policies at the University in fall 2021. Over half of employee respondents, and close to half of student respondents assess them as being *about right*. (See Table 25.)

Respondents were then asked to reflect on the current testing policies. Less than half of employee respondents (43%) consider those to be *about right*, and a similar number consider them to be *less than they would like*. Students appear to be more satisfied with these policies, with close to half considering them to be *about right*, and only 29% considering them to be *less than they would like*. (See Table 26.)

Both employees and students appear to be less satisfied with the current face-covering policies<sup>2</sup> than they are with the current testing policies; 39% of employees and 28% of students consider them to be *about right*. It should be noted, however, that 50% of students consider the “current” face-covering policies to be *more than they would like*, while only 29% of employees think the same way. (See Table 27.)

Over half of responding students report having been required to quarantine or isolate during the past two years of the pandemic. And over half (57%) of those assess the support and care they received from the University during their quarantine as *not very good* or *not good at all*. (See Table 28 and 29.)

Respondents were presented with a set of more general statements regarding the University’s handling of the COVID-19 pandemic. Overall, employees were quite positive in their assessment:

- “The University took precautions to ensure employees /students safety during the coronavirus pandemic.”--78% of employee respondents *strongly agree*, or *somewhat agree* with that statement. (See Table 30.)

- “I understand the safety protocols being implemented to prevent COVID-19 infections.”--76% of employee respondents *strongly agree*, or *somewhat agree* with that statement. (See Table 32.)
- “I understand the importance of screening employees / students for symptoms of COVID-19.”--84% of employee respondents *strongly agree*, or *somewhat agree* with that statement. (See Table 33.)
- “I understand updated University of Wyoming health and safety policies/protocols that are being put in place as a result of the COVID-19 pandemic.”--70% of employee respondents *strongly agree*, or *somewhat agree* with that statement. (See Table 34.)

Students’ perceptions seem to be in line with those of employees, though smaller majorities *strongly agree*, or *somewhat agree* with these statement.

Respondents to the survey are somewhat less satisfied with the institution’s communication during the pandemic crises – only 56% of employee respondents *strongly agree*, or *somewhat agree* with the statement “The University provided timely and clear communication during the crisis.” Student responses follow the same direction as those of employee respondents. Close to, but still less than half of student respondents *strongly agree* or *somewhat agree* with the above statement. (See Table 31.)

The comfort levels of employees and students with regard to fear of contracting the virus from co-workers/students, are quite different. Only 33% of employee respondents *strongly agree*, or *somewhat agree* with the statement: “I have no fear of contracting the virus from co-workers/students.” While a majority (56%) of student respondents *strongly agree*, or *somewhat agree* with the same statement. (See Table 35.)

Respondents were presented with a list of possible safety measures and asked if they want to see them at the University. Presented below are the six chosen by a majority of employees, presented in descending order of the number of affirmative responses. (See Table 36.)

As can be seen in Table 5, hand sanitizer stations are favored by large majorities of both employees and students. University provided masks are also an item about which employees and students feel alike. Beyond these two measures employees and students are not in agreement.

The responses to the question designed to measure comfort levels with learning or working in-person at the university at this moment in time are a logical continuation to the responses to the question regarding fear of contracting the virus from co-workers/students. While 70% of student respondents indicate that they are *extremely* or *somewhat comfortable* learning in-person at the university, a slight majority (58%) of employee respondents indicate that they are *extremely* or *somewhat comfortable* working in-person at the university. (See Table 37.)

Respondents were further prompted to indicate what measures would increase their comfort levels of working/learning in-person at the university. Results are very telling of UW employee's sentiments on that subject. Of the nine named measures, three were selected by half or close to half of all employee respondents: *mandatory vaccine requirement* (52%), *mandatory face covering requirements* (49%), *public health regulations being followed* (49%). (See Table 38.)

In closing, respondents were asked if they see any downsides to the "remote" work arrangements available to UW personnel at this point. Although the majority (55%) of employee respondents appear to not see any downsides to these arrangements, still close to half (45%) do see downsides. (See Table 40.)

# Survey Results

This section of the report contains the responses to all substantive close-ended questions included in the survey.

Raw frequency counts and percentage distributions of responses are presented broken down by the major respondent categories of *employee* or *student*.

*No answer/Refused* values are excluded from the valid percent calculations.

On *Select all that apply* items percentage may total more than 100.

If a particular question was asked only of a certain subgroup, there is a notation to that effect.
