

UW and Frontier Carbon Solutions selected for \$40.5MM from DOE for CarbonSAFE Project

- In May 2023, US DOE announced it had selected UWyo's School of Energy Resources and Frontier Carbon Solutions to negotiate a **\$40.5mm** grant over three years to support the development of a "new and expanded large-scale, commercial carbon storage project" in the Great Green River Basin the Sweetwater Carbon Storage Hub
- One of nine projects receiving a total of **\$242mm** under the "Carbon Storage Validation and Testing" category under the Bipartisan Infrastructure Law aimed at "expanding carbon dioxide transportation and storage infrastructure
- Projects selected are focused on **detailed site characterization**, **planning and permitting stages** of project development under **Phase 3** of the Office of Fossil Energy and Carbon Management's Carbon Storage Assurance Facility Enterprise (**CarbonSAFE**)





- "SAM" Applicant must register with the System for Award Management
- "UEI" Applicant must obtain a Unique Entity Identifier
- "AOR" Each grant application must identify and register an Authorized Organization Representative
- Must also register with Grants.gov and **FedConnect**

2. What are You Applying For?



- Follow the letter for the FOA
- You cannot overload the application with data and details
 - Be prepared to effectively demonstrate the social and environmental benefits of your project
- Remember after the notification, it's a <u>negotiation</u>

3. Who are you Applying with?

- If not your organization, who is your Primary Authorized Organizational Representative?
- For Frontier, **UW School of Energy Resources** has been an **ideal partner**

 - Saved us considerable time and resources to avoid lengthy "AOR" process
