#### LABOR DAY MAKE UP DAYS

As a reminder, the University authorized two additional personal days for all UW employees, to be used before the end of the calendar year. Employees will need to follow the standard processes for requesting time off, in collaboration with and approval by supervisors. The extra personal days will be tracked in this manner:

- -- For salaried exempt employees, managers will track the days manually -- they will not be added to the HCM system, and they will be used in whole-day increments.
- -- For salaried non-exempt employees, 16 hours will added to the Comp Bank and are to be used with normal Comp Bank rules established in the units. The hours will be prorated for part-time workers, if applicable.
- -- For hourly non-benefited employees, the payroll office will set up a new time-reporting code; the hours will be prorated to their full-time equivalent status; supervisors will track usage entered by employees into the timekeeping system; and units will establish rules for use.

# CENTER FOR CARBON CAPTURE AND CONVERSION

Carbon Engineering moves its Proprietary Coal Conversion Process into Pilot Plant Testing Phase Three pilot plants (pyrolysis, solvent extraction and CO2 Conversion) were recently completed and are now being commissioned. The pilot plants, once fully operational, will produce feedstock intermediates, to assess the long term performance of products being made from Wyoming coal. Results will also be used to establish the design, further scale up, integration of these processes into a coal refinery field demonstration facility, which is planned for 3 years' time.

## Research and Technology Master Agreement Established with Atlas Carbon, LLC

The agreement is to work together on developing technologies that can convert Wyoming Powder River Basin coal into value-added non-energy and fuel products, bringing together UW's proprietary thermo-chemical process technology for conversion of coal into wide ranging intermediate materials that can be converted into end products, and Atlas Carbons, proprietary technology for making activated carbon.

UW's Grana Teaches New Diversity Course in Geosciences

Typically, when one thinks of a geoscientist, visions of an outdoorsy person come to mind. If you type in "geoscientist" photos on Google, a series of images pops up of students and researchers hiking in a canyon collecting rocks.

"This is mostly a stereotype, but it creates an implicit bias that limits recruitment of scientists with disabilities, as well as students who are not very outdoorsy, even though there are many branches of geoscience that focus on computational work," says **Dario Grana**, an associate professor in the University of Wyoming Department of Geology and Geophysics.

As a result, the geosciences have suffered from a lack of diversity in the classroom, both among faculty members and students, according to Grana.

Grana has provided an opportunity to explore the topic in a new one-credit course, titled "Diversity and Inclusion in Geoscience," that began this fall. Students have the chance to interact with a diverse group of scientists; learn about the challenges that underrepresented minorities have to face in academia, their career paths and research projects; and diversity, equity and inclusion initiatives that they promoted.
