Phase III Application Instructions

Phase III is a two-semester sequence at the end of your teacher education program. The first semester, Phase IIIa consists of Methods class(es). Elementary majors are strongly advised not to take additional classes during Phase IIIa. The second semester, Phase IIIb is a full 16-week Residency (student teaching) experience in a public school setting.

- Make sure you will have completed all prerequisites for Phase III (see page 2) prior to the semester in which you plan to enroll.
- **The most recent download of Adobe Reader is REQUIRED to complete the application. DO NOT USE FOXIT or other PDF viewers as the document will not work properly.**
- Before you begin to complete the application, download and save the application form to your hard drive and to an alternative source.
- ***ALL application and all supporting documentation, except for the copy of your Wyoming Substitute Teaching Permit, must be computer printed and single-side printed or copies.*** The Wyoming Substitute Teacher Permit copy must be the original size and double-sided as is the original certificate.
- Gather all supporting documentation. See *Additional Information* on the following page.
- Use the checklist on page ‘i’ of the application to ensure that you submit all required materials. Do not staple or 3-hole punch your application materials.
- Make a complete hard copy for your files.

- Late applications may not be accepted. Students may apply during the next application cycle.

Prerequisites for full admission into Phase III:

- 2.75 UW Total Institution grade point average (GPA) minimum.
- 2.50 major content GPA minimum.
- Application through the UW Admissions website for the Graduate Certificate in Teaching has been submitted and has been approved prior to the start of the summer certification courses.
- The following must be passed with a grade of C or better (grades of C- will not fulfill these requirements):
 - Professional Education sequence prerequisites: EDST 2450 and ITEC 2360 or approved substitutes
 - Summer Professional Ed course sequence: EDST 4000 and EDEX 2484 and EDCI 5550
 - Fall Professional Ed course sequence: EDCI 5250 and EDCI 5870 and
 - Elementary ONLY: EDEL 4109, EDEL 4309, EDEL 4409
 - Secondary & Art ONLY: EDSE 427x (according to your content major)
 - EDST 3550
- Elementary majors must have completed all content course work by the end of summer semester 2017.
- Secondary majors must be within 6 credit hours (total) of completing your secondary area content course work at the end of fall semester 2017.

Complete the Phase III application NOW if you expect to enter Phase IIIa in fall 2017.

Additional Information:

TRANSCRIPTS: Originals or photocopies (front & back) of your current transcripts from all institutions you have attended must be submitted with your Phase III application.

Please do NOT ask the UW Registrar's Office for transcripts from another institution. The UW Office of the Registrar is prohibited by federal mandate from releasing other college/university transcripts to you. You must request transcripts from all other institutions you attended. Ask the institution(s) to mail transcripts directly to you. Keep the one(s) you receive; **make a copy** and attach the copy to your Phase III application. Do not ask the institution(s) to mail or fax transcripts to the Office of Teacher Education. **Faxed transcripts will not be accepted.**

NOTE: If you are currently enrolled in a course at one or more colleges or universities, *it is your responsibility* to have transcripts sent or bring in official copies of your transcripts to the UW Office of Teacher Education (OTE) *immediately* after grades for those courses have been posted. If you continue to take classes at another college or university prior to or through the Phase IIIa and Phase IIIb semesters, have your transcripts sent at the end of each semester to the OTE.

SUBSTITUTE TEACHING PERMITS: A **single page** photocopy of the **front and back sides and in its original size**, of the substitute permit must accompany this application. Application information for the permit is available in the Office of Teacher Education, school district offices and from the Professional Teaching Standards Board in Cheyenne (1-800-675-6893).

FEES: (***SUBJECT TO CHANGE***) There will be a \$90 Methods (IIIa) fee assessed at the time tuition is remitted for the semester enrolled. The Residency in Teaching (IIIb) fee will be \$20.00/credit hour not to exceed \$320.00. The fee will be assessed at the time tuition is remitted for the Residency semester.

PLACEMENTS: Upon review of all Phase III applications in this cycle, a departmental faculty committee will determine the district for initial consideration of your application. Your placement will be determined by UW faculty and school district personnel and the availability of quality mentor teachers in the Partner School sites in Wyoming. Placements in non-Partner School districts will be rare except for agricultural education majors. Partner School sites are listed on page ii of the application form.

Phase III applicants WILL NOT be placed in the following situations: in the same building they attended as a student; in a building where the applicant's children are enrolled; in a building where a spouse or other relative is employed; in a building where a relative is attending school; with a cooperating teacher who is a relative. Phase III students will not be placed in a parochial school (United States Court of Appeals, Eighth Circuit, 1986, Stark and Sentz, Appellees v. St. Cloud State University, Appellant).

EMPLOYMENT: We strongly discourage students from attempting outside employment while in Phase IIIb. Participation in intercollegiate athletics or other on-campus activities will also be very difficult.

REGISTERING FOR CLASSES: Students will register for Phase IIIa courses using their PERC number. PERC numbers are available with a photo ID in the Office of Teacher Education. Phase IIIb registration will occur via UW Outreach. Details for Residency registration will be shared with students before the end of fall semester. Registered students who do not meet the requirements for Phase IIIa or b will be administratively dropped.
