Simple Summary of 2017/2018 University of Wyoming Budget Exception Requests

University of Wyoming, Section 067 Priority Item Request Funded

NOTE: "Penny Plan" cut: Reduces generally funded budgets by 1.5% in 2017 and 2018. This cut resulted in a \$5.79M cut to UW's block grant. Other units within UW's budget were also reduced by the "penny plan": NCAR by \$30K, SER by \$8,308.

NOTE: Section 330 of the budget bill (SF1, SEA 19) directs agencies to prepare budget reductions of 3.5% in FY 2019 and 5% in FY 2020, based on their FY 2017-2018 GF Standard Budgets. In addition, agencies may be asked to submit plans for further reductions to their FY 2018 budgets if revenue forecasts decline.
