EXECUTIVE SUMMARY:

At the March 2019 UW Board of Trustees meeting, Trustee President Dave True informed the Board of Trustees of a letter and check in the amount of \$10,000 he received as a gift from Adam Glick and the Blue Guitar Foundation in recognition of the recent marking campaign, "The World Needs More Cowboys." The Trustees held a brief work session to discuss the matter and determined the funds would be used to create scholarships that would support the academic pursuit of two students. The UW Board of Trustees took action to create two \$5,000 scholarships with unrestricted funds received from the Blue Guitar Foundation, with the scholarship criteria to be developed by the President's Office and Associate Vice Provost for Enrollment Management Kyle Moore.

It has been determined that the Office of Scholarships & Financial Aid will select two new incoming students to receive this scholarship for the 19-20 academic year. A \$5,000 scholarship will be awarded to a recent Wyoming high school graduate and the remaining \$5,000 will be awarded to an incoming Wyoming community college transfer student. The funds will be split evenly across two semesters of enrollment. Both students must meet the following criteria:

- be Wyoming residents
- have financial need as demonstrated through the FAFSA
- have a cumulative high school or transfer grade point average of a 3.0 or above

PRIOR RELATED BOARD DISCUSSIONS/ACTIONS:

As noted above, this topic was discussed at the March 2019 Board of Trustees Meeting.
