Trustee John McKinley reported the March 22-24, 2023, UW Board of Trustees Meeting minutes (executive and public session) will be approved during the May 2023 meeting.

AGENDA ITEM TITLE: <u>Update</u> – Seidel

MINUTES OF THE MEETING:

UW President Ed Seidel provided a report to the Board and discussed the University of Wyoming hosting a National Lab Day event April 12-15, 2023, during which 17 national labs will be represented. President Seidel stated 250 individuals were registered and that the event is a valuable employment recruitment opportunity for students. President Seidel went on to report Governor Gordon announced he has advanced the second phase of the Wyoming Innovation Partnership (WIP). President Seidel highlighted approved funding for the creative economy to include support for the Neltje Center for Creativity and the Arts; Controlled Environment Agriculture (CEA) which accompanies previous investment of state funds toward Plenty and its research and development expansion in Laramie; and support for Blue Hydrogen. President Seidel next discussed work toward the execution of his presidential goals and the university's Strategic Plan 2023+. The president discussed moves toward strengthening the foundations of the university and said that Vice President for Research and Economic Development Parag Chitnis and Provost and Executive Vice President for Academic Affairs Kevin Carman were examining campus institutes and centers to recommend next steps forward. President Seidel discussed examination of ways in which to foster freedom of expression on campus, and efforts to foster external relations. President Seidel discussed efforts to develop and implement a transparent budget allocation model that enhances incentives for growth consistent with the university's mission and stated as part of his annual report during the July Board meeting about UW Fundraising Priorities, he will share plans for a capital campaign to enhance philanthropy. President Seidel closed his report stating College of Education Dean Scott Thomas has accepted a position at Sterling College effective July 1, 2023.

Trustee Brad Bonner provided the Board a brief summary of the work of the Freedom of Expression, Intellectual Freedom, and Constructive Dialogue Working Group expressing his appreciation for being invited to take part in the committee discussion, and stated recommendations are forthcoming by end of Spring semester with a formal report to the Board at a future meeting.

In response to inquiry from Trustee John McKinley, Provost Kevin Carman provided update on identifying low enrollment degree programs with a formal report to the Board at a future meeting. Trustee Kermit Brown requested cost of the degree programs should be considered alongside enrollment thresholds.
