HAIMAL PRODUCTION NEAL HILSLON Named Heting Head No. 3—Clearing the site for the new Agriculture building, \$5,582.50, is to be taken from the appropriations for the construction of this building if funds are available. No. 2—Stone for Old Main—\$378.00 is to be taken from the appropriation for this building if funds are available. No. 5—Installation of exit lights in the new Bookstore—Art building—\$62.70 is to be paid from Bookstore funds.

The President reported that the Legislature, at the special session in June, appropriated a maximum of \$51,000 for the completion of Old Main. There was approximately \$11,000 remaining in the original contract, making—with the new appropriation—a total of about \$62,000. On August 4, therefore, the President approved the following changes and additions to the contract for a total of \$58,913 (not including the Architect's fee), leaving a little margin between the amount appropriated and the amount to be spent. These changes will enable us to complete Old Main in accordance with the original contract.

President Humphrey then submitted the following statement prepared by Dean W. C. Reusser and recommended its adoption. Mr. Watenpaugh moved, it was seconded by Mr. Sullivan and carried that the statement be approved.

"Compensation of part-time employees in University Centers is based upon the number of credit hours taught when 16 hours is considered a full load. In the case of laboratory work, two clock hours per week shall be considered the equivalent of one credit hour. In the case of work that cannot be adequately measured in terms of credit hours, e.g. coaching, the number of clock hours shall be considered the basis with a full load considered as 40 clock hours per week. A high school teacher

doing part-time work in the University Center shall be paid in proportion to the time at his present salary rate, not to exceed the maximum salary figure of \$3,360 except in special cases, e.g. a high school teacher teaching one three-hour course for one quarter shall be paid \$210 for the quarter. This is computed at the rate of 1/16 of \$3,360. Part-time salaries are paid entirely during the quarter in which the work is done. They may be paid in monthly installments or in one lump sum at the option of the teacher. Part-time employees do not receive contracts. They are employed on the basis of a letter and the request for employment. The request for employment should be renewed each quarter in order to adjust for different teaching loads."

Mr. Sullivan then moved that the following policy covering patents be approved as recommended by President Humphrey with the stipulation that the Board should review applications for patents as they may arise.

Patents.

The committee that you appointed to suggest on all University patent policy submits the following report. The committee has made considerable use of the preliminary report entitled "Survey of University Patent Policies," by Archie M. Palmer, prepared this year by the National Research Council. The committee feels that any patent policy must differentiate between patents based upon:

(1) Personal research

(2) Institutionally supported research

(3) Research sponsored by an outside company with which the University has a contract.

This committee recommends that a committee on University Patents be set up as an administrative committee to consist of the following members:

The chairman of the executive committee and the Director of the Natural Resources Research Institute.

The Dean of the Graduate School.

(3) The Director of the Agricultural Experiment Station.

(4) The Director of the Engineering Experiment Station if one is appointed.

(5) Not more than three members of the faculty or staff appointed by the President if he so desires.

The functions of the committee on University patents shall include:

- (1) To receive and consider applications from staff members desiring to secure patents at University expense and with University participation in profits and control.
- (2) To appoint sub-committees of the University staff to advise on technical phases of patent applications under consideration.
- To consider the business aspects of such applications.
- (4) To consider and recommend to the President agreements covering licensing under patents secured and assigned to the University.

(5) To consider and recommend the selection of a patent counsel for the University to make formal applications for patents.

(6) To consider and recommend to the President agreements with faculty and staff members relative to the percentage of income to be received by the individual inventor and relative to the assignment of patents by the faculty and staff members to the University by determining the amount of University time, equipment and funds used in developing the idea; whether or not funds used in the development of the idea were University, personal, donated, or sponsored funds.

BE IT RESOLVED by the Board of Trustees of the University of Wyoming that the receiving of the bids for the erection and completion of the remaining unit of the Agriculture Building be continued from 2:00 P.M., as advertised, until 8:00 P.M. on the 27th day of September, 1948;

BE IT FURTHER RESOLVED that the President and the Secretary of the University and any Trustee or Trustees who may be present are hereby authorized to receive said bids, and that the Executive Committee shall be empowered to examine and analyze said bids, accept same, and authorize the letting of the contract to the lowest responsible bidder, provided that said bid is within the appropriation for the building and erection of said unit of the Agriculture Building.

Mr. DelMonte moved that the Secretary write letters to Governor Hunt and Senator O'Mahoney thanking them for their efforts in helping us to purchase cement for the new buildings. Seconded by Mr. Sullivan and carried.

Resolution Rec'ing of bids changed from 2:00 to 8:00

1948

Mr. Sullivan moved that \$1,600 be appropriated and the bid of the Wyoming Construction Company be accepted for moving selected top soil, approximately 4,000 cubic yards, for the grading of Prexy's Pasture. Thi motion was seconded by Mr. DelMonte and carried.

Mr. Sullivan moved that the bid of the Warner Brothers' Construction Company of Denver be accepted in the sum of \$11,220 for the installation of an underground watering system in Prexy's Pasture. This motion was seconded by Mr. DelMonte and carried.

The Board then received Mr. Linvingston, Mr. Raymond Davis, Mr. William Nightingale, members of the Board of the Sweetwater County Memorial Hospital from Rock Springs, Miss Gould, Dean Reusser, Dr. Clarke and Dr. Denniston from the University for a discussion of the Rock Springs Nurses Nurses Training School training school. The Board approved the appropriation of the sum allocated by the Legislature for General Extension work at Rock Springs, in the amount of \$300.00 per month beginning September 1 and ending April 1, for the nurses training program at Rock Springs. The President was instructed to notify the Board of Trustees of the Sweetwater County Memorial Hospital that they might organize extension courses from which the nurses could receive part of their instruction. The President was authorized to work out, in cooperation with the various interested groups in the state, a plan to be presented to the Legislature for providing a complete program of nurses training for the State of Wyoming.

President Humphrey then informed the Board that the time has come to prepare the budget for the next session of the Legislature which convenes in January 1949. After discussion, Mr. Sullivan moved that the amount of money requested for University salaries should be increased sufficiently to cover merit and promotion raises only. This motion was seconded by Mr. DelMonte and carried.

Mr. Sullivan then moved that the money requested for supplies should be increased enough to cover increases in prices. This motion was seconded by Mr. DelMonte and carried.

Board of Trustees

Mr. Watenpaugh moved that modest requests for appropriations for equipment be made at the next session of the Legislature, including A and B sections of the Agriculture Building, Old Main, Wyoming Hall and additions to Knight Hall (cafeteria, music department, and dormitory rooms), and that equipment for the Education Building and C section of the Agriculture Building be requested at future sessions of the Legislature, when these buildings are nearing completion. The motion was seconded by Mr. DelMonte and carried.

Budget Legislature

Then followed a discussion of the donations to the Memorial Stadium Field house fund. Mr. Burwell moved that funds needed over and above the Memorial (Stadium) contributions be based on a 50% request to the Legislature for an appropriation and the balance of 50% to be a bond issue authorized by the Legislature. This motion was seconded by Mr. Sullivan and carried.

It was then moved that upon the completion of the new Agriculture and Education buildings, it will be necessary to remodel the old Agriculture and Normal buildings. Mr. Sullivan moved, it was seconded by Mr. DelMonte and carried that the request for funds for the remodeling of these old buildings be deferred until the Legislature of 1951.

Mr. Watenpaugh moved that a request to the Legislature for a new library and student infirmary should not be made at this coming 1949 session. This motion was seconded by Mr. Sullivan and carried.

Mr. Watenpaugh then moved that it is the policy of this Board to conon a sound basis and President Humphrey is instructed to proceed along Community Service Reduce to Community Service. these lines in his preparation of the budget to be submitted to the coming session of the Legislature. The President was also instructed to

prepare a bill for presentation to the Legislature incorporating a statewide center program as part of the plan for higher education in Wyoming. This motion was seconded by Mr. Sullivan and carried.

Mr. Sullivan moved that Dr. Clarence D. Jayne's title be changed to Administrative Assistant in the Division of Adult Education and Community Service. This motion was seconded by Mr. DelMonte and carried.

President Humphrey informed the Board of the difficulty in keeping the several food services on a sound financial basis. After considerable discussion President Humphrey was authorized to request Crotty Bros. Inc. of Chicago and Boston to send a man here to investigate and study our several restaurants and make recommendations to remedy the situation. President Humphrey is authorized to submit these recommendations to the Executive committee who are hereby granted power to act. This motion was seconded by Mr. Watenpaugh and carried.

The Board adjourned sine die 6:00 P.M., Sunday, September 26, 1948.
