A visitation meeting of the Trustees of the University of Wyoming was held on Thursday, March 16, 1972, in the Board Room of Old Main. President True called the meeting to order at 10:00 a.m.

The following members were present: Brodrick, Bunning, Hickey, Hines, Hollon, Jones, McBride, Ostlund Quealy, Sullivan, True, and ex officio members Carlson and Berry. Members absent were: Pence and ex officio members Hathaway and Schrader. Executive Staff present were: Jim Ranz, Vice President for Academic Affairs; Elliott Hays, Vice President for Finance; Joseph Geraud, Vice President for Student Affairs; and Hugh B. McFadden, Vice President for University Extension. Dr. Donald Anderson represented the Faculty Senate, and Calvin Rerucha, President-elect of the Associated Students of The University of Wyoming, was present on invitation of President True.

It was moved seconded, and carried that the minutes of the meeting of February 18, 1972, be approved as circulated.

President Carlson announced that the Trustees would have lunch at Knight Hall with the Dean of the College of Agriculture and the Head of the Division of Plant Science, and with the Dean and department heads of the College of Commerce and Industry.

It was moved, seconded, and carried that the meeting go into executive session with the executive staff invited to remain. The meeting recessed at 11:00 a.m. to reconvene at 4:00 p.m.

For the next hour the Trustees visited the Division of Plant Science VISITATIONS: in the College of Agriculture. APPO INTMENTS

It was moved, seconded, and carried that the following appointments be approved as recommended by the President for the periods indicated, subject to any salary adjustments which may be required to conform with the Federal wage-price freeze.

- 1. The appointment of Frank W. Henderson as Acting Assistant County Agent for the period April 1, 1972, through March 1, 1973, on an 11-month basis.
- 2. The appointment of Eugene A. Huey as Assistant Football Coach for the fiscal year from July 1, 1972, through January 31, 1973.

It was moved, seconded, and carried that changes in assignment for the following personnel be approved as recommended by the President.

- 1. Gerald M. Morel, presently Assistant County Agent in Goshen County, as Acting Goshen County Agricultural Agent, for the period March 20, 1972, to March 1, 1973.

BUDGET CHANGES

It was moved, seconded, and carried that the following budget changes be approved as recommended:

Board of Trustees. An additional appropriation of \$2,500 for the Contractual budget is requested for the remainder of the fiscal year. This supplement is required to meet charges accruing to this account, which are greater than anticipated when the budget was prepared.

President's Office. An additional appropriation of \$5,560 to be allocated as follows: Contractual, \$1,760; Supplies, \$1,000; Travel, \$2,800. These funds are needed to meet anticipated expenses for the remainder of the fiscal year.

In analyzing the 1969-70 and 1970-71 expenditures, it was found the following amounts were actually spent on each category as compared to the budgeted and requested amounts for 1971-72.

### REPORT OF THE VISIT OF THE BOARD OF TRUSTEES TO THE PLANT SCIENCE DIVISION

Members of the Board of Trustees visited the Plant Science Division from 11:15 A.M. to 12:15 P.M. on Thursday, March 16, 1972.

Dean Hilston welcomed the Trustees and presented a brief history of the College of Agriculture and its seven component divisions of instruction and research.

Dr. Painter, Head of Plant Science, briefly discussed the function of the Division. There are presently 28 faculty members, including six extension specialists, in the various subject matter areas of Crop Science, Entomology, Plant Pathology, Horticulture, Range Management and Soil Science. Four of the extension specialists hold joint appointments in that portion of their time is budgeted to research and/or teaching. The Division had 44 graduate and 86 undergraduate majors enrolled in the fall semester of 1971-72. Research is presently being conducted in 48 authorized projects directly concerned with state, regional and national needs. The Division is in the process of acquiring a badly needed research facility, the Plant Science Laboratory complex, which was authorized by the State Legislature in 1969. The present facility, constructed in 1941, was designed for use by five faculty and five graduate students and is extensively shaded by later building. The new facility, to be constructed on a 7.1 acre tract directly north of the National Guard Armory, will have three teaching and six research laboratories, one cold room, two storage and preparation areas and isolation areas for various studies to be conducted in the attached glass houses. Four to six glass houses will be constructed with controlled temperatures and humidity to permit maximum use throughout the year. There are plans to install growth chambers to facilitate additional controlled environment experiments.

Dean Hilston then presented three faculty members who briefly discussed some aspects of their current research studies. Dr. John E. Lloyd, Assistant Professor of Entomology briefed the group on the magnitude of the mosquito problem in the Laramie area. This study was initiated to determine the species of mosquitoes in the area and to determine the effectiveness of various insecticides on the insects and on non-target organisms. A larval and adult survey from 22 different sites around Laramie produced six species, many occupying the same water. The species identified are not only a nuisance to human and livestock populations but over 90% of the collected insects are capable of carrying and transmitting encephalitis. Control of the insects will be difficult with the large acreage of potential breeding sites in the Laramie area and until better biological controls are developed such control will be dependent upon use of insecticides.

Dr. Morton May, Professor of Range Management, discussed the development of strip mine reclamation studies for the past six years. Initial studies, on spoil banks near Kemmerer and in cooperation with the Kemmerer Coal Company, included methods of establishing native and introduced grasses, forbs and shrubs on spoils varying from 1 - 14 years in age. Other treatments studied included use of fertilizer, sprinkler irrigation, snow fencing and mulching to assist in plant establishment in

the extremely arid area of the sites, less than 9.0 inches of annual

precipitation. New studies presently being conducted are in conjunction with the development of strip mining activity at the Jim Bridger Site near Rock Springs and are being financed by Pacific Power and Idaho Power Companies. These studies are being initiated prior to mining operations and will permit determination of present ecology of the area as well as types of revegetation suitable.

Dr. Paul Singleton, Associate Professor of Soils, discussed the accumulation of heavy metals such as lead, silver, chromium and nickel in soils and plants. One study has been established along the adjacent lands of Highway I-80 between Laramie and Wolcott Junction. This route was chosen because prior to opening of the highway in 1970 the area had been exposed to a minimum of vehicular use and would provide excellent baselines values for determination of accumulation of metals from subsequent exposure to gasoline engine emissions. Another study has been initiated to determine the effect of Silver Iodide from weather modifications target area and subsequent studies will be made to determine the disposition of silver in the soils and plants of the area. Dr. Singleton concluded by briefly discussing proposed studies on use of the soil as a waste disposal system.

The faculty members answered questions of the Board members concerning the research presented until 12:15 when the visitation was adjourned.
