MINUTES OF THE TRUSTEES

July 13, 1995

Following a breakfast with Staff Senate members and liaison visits with various University units, the Board of Trustees of the University of Wyoming held a regular business meeting on July 13, 1995 in the Old Main Board Room. Committee meetings and an executive session to discussion personnel and litigation matters were held on Wednesday, July 12, 1995.

President Walter G. "Jerry" Saunders called the meeting to order at 10:10 a.m.

ROLL CALL

The following Trustees attended the business meeting: Walter G. "Jerry" Saunders, Deborah Healy Hammons, Harry L. Harris, Peter M. Jorgensen, Elizabeth A. Kail, Forrest "Frosty" Kepler, Daniel L. Kinnaman, Jeri Kirk, Rita Meyer, Shelly Ritthaler, and Hank True. <u>Ex-officio</u> members UW President Terry P. Roark and ASUW President Sam Krone were also in attendance. Dave Bonner was absent. <u>Ex-officio</u> member Judy Catchpole was present for the committee meetings on Wednesday, but was unable to attend the business meeting.

PRESIDENT'S REPORT

President Roark reported the following information items to Trustees:

Sponsored awards at the University of Wyoming totaled \$34,132,000 for the fiscal year 1994-95. This figure represents the ninth consecutive year that UW faculty and staff have set a new record in sponsored award funding.

- Wyoming's EPSCoR strategic initiative proposal has been funding by the National Science Foundation. While the budget is still under negotiation, a recommendation has been made for UW to receive \$4.2 million. There also is a considerable state and external match associated with the EPSCoR proposal.
- Two UW students Jeffrey H. Schenker and Matt E. Monroe, both of Laramie -- won prestigious Goldwater scholarships this year, making us competitive in that area. Other institutions with two winners include Harvard, Arizona State University, UCLA, and the University of Minnesota.
- The University's Title IX survey of interests and abilities was the subject of a scholarly article published in the journal Educational and Psychological Measurement. The article was written by Martin M. Greller, Robert S. Cochran, and Patricia A. Taylor, who guided the UW study.
- In response to rider demand, the Transporter bus service has been expanded through the summer. A second bus has been added and the Transporter route has been extended to serve west Laramie.
- A management audit of the American Heritage Center has been completed by Paul H. McCarthy, head librarian emeritus at the University of Alaska. He was generally complimentary of the progress of the center since 1988 and has offered some novel, yet sensible, strategies for the future of the center.
- The University house formerly used as the president's residence has been sold to a long-time Laramie resident for \$240,000. The new owner plans to use the property as a private residence.

Former Trustee Harold F. Newton of Sheridan has donated \$25,000 to UW's new

livestock teaching center. The center will be named in honor of Cliff and Martha Hansen.

Dee Pridgen has been selected as the new Centennial Professor in the University of

Wyoming College of Law.

President Roark also reported receiving a report from Dean Hakes indicating that

engineering students who took the "Fundamentals of Engineering" exam this spring scored

92 percent. This leads the national average by a very wide margin.

President Roark also shared the student loan default rate data provided by John

Nutter, Director of Student Financial Aid. The 1993 default rate (the most current

information available) was at 4.3 percent, which is a return to UW's historic range of 4

percent. The 1992 rate was 5.3 percent. President Roark said it reflected very well on the

responsible attitude of our students.

APPROVAL OF MINUTES

It was moved by Trustee Kepler, seconded by Trustee Harris, and carried that the

May 12, 1995 Minutes of the Trustees be approved.

ACADEMIC AND STUDENT AFFAIRS COMMITTEE

President Saunders asked Chairperson Hammons for a report from the Academic and Student

Affairs Committee meeting held on July 12, 1995. Committee members Hammons, Catchpole,

Jorgensen, Kinnaman, Kirk, and Ritthaler attended the meeting, along with other Trustees and

University personnel. The following items were presented to the full Board:

WAMI

An update on the status of the University of Washington WAMI (Washington, Alaska, Montana, Idaho) program was a discussion item for the Academic and Student Affairs committee.

Trustees are considering a change in affiliation from Creighton Medical School to the WAMI consortium.

College of Health Sciences dean Martha Williams summarized the written material presented to Trustees several months ago and information provided to Trustees at their March 18, 1995 meeting which compared the WAMI consortium and Creighton University's programs.

Currently, the University of Wyoming sends 10 medical students per year to Creighton University in Omaha, Nebraska. Creighton is a private medical school, and the University of Wyoming essentially purchases seats at Creighton. The medical contract officer at UW, Dr. Robert Marlow, director of the Cheyenne Family Practice Center, and a UW campus committee interview prospective contract students and make recommendations to the admissions office at Creighton. Final selection is made by a committee at Creighton. The students signs a loan contract agreeing to pay back the cost of the seat plus interest beginning one year after completing medical school and a residency or they agree to practice medicine in Wyoming for a period of three years. Tuition at Creighton is currently \$5,000/year. January 1995 figures indicate that 23.8 percent of the 323 medical contract graduates of Creighton or Utah were residing in Wyoming. This included eight residents at the Wyoming Family Practice centers.

Dean Williams reported that there has been very little contact with the home state or between the University of Wyoming and Creighton University in this program. The contract program has had

few implications for other UW programs, and no research activities have been undertaken.

Dean Williams said that WAMI's goal is to provide medical education in the states with continued University and student interaction with the home state. WAMI requires that the first year of medical school be completed at the home campus, with home campus faculty. The second year is spent at the University of Washington. The third and fourth years are set aside for medical and clinical rotations. The University of Washington would work with Wyoming in developing programming. The WAMI return rates to home states averages 42 percent. Participating WAMI states have seen a 76 percent return rate for students from the home or other WAMI states.

Dean Williams reported that the University of Washington is very reception to other collaborative programs and interdisciplinary joint activities such as nursing, pharmacy, health administration, dentistry, physical therapy, social work, occupational therapy, environmental health, and physician assistance. The University of Washington also hosts a number of postdoctoral fellowships. Family practice residency network affiliation is available to WAMI states. This network provides opportunities for interchange among physician faculty for continuing education, consultation, research, and sharing of curricular design and training methods for resident teaching. Dean Williams said that the University of Washington has a special focus on native American Indian health care.

One of the unique features of the University of Washington program is that approximately 21-43 percent of the WAMI costs are reinvested in the state.

Among all medical schools, the University of Washington is ranked very high, with quality comparable to any medical school in the country. The University of Washington was ranked first in family medicine, first in rural medicine, third in women's health, fourth in pediatrics, and fifth in

AIDS care in a recent <u>U.S. News and World Report</u> survey. They are ranked consistently in receipt of federal research funding, and many University of Washington faculty are recognized nationally.

President Roark recommended that Trustees approve the WAMI program and phase out the Creighton program. Prior to implementation of the program, a new anatomy lab would have to be built, and a full-time faculty person to teach anatomy would need to be recruited and hired. The first class would enter in the fall of 1997.

UW would continue the University of Washington program under a loan program as is done now with Creighton. An option would be to require students to pay back their loan with four years of service rather than three. President Roark also recommended that UW accept 15 students per year under WAMI instead of 10 as in the present program with Creighton. He also recommended that UW charge WAMI students tuition of \$7,500 per year, to be reviewed each year by Trustees as they do now with other tuition increases. Creighton University students students would be charged the current rate of \$5,000 per year until the program is phased out. By the year 2000, the WAMI program would be fully implemented.

President Roark also provided anticipated tuition increase figures, program cost comparisons, and the estimated costs of WAMI. Four to nine percent tuition increases have occurred each year. In the coming biennium, UW would need an appropriation of \$750,000. That figure would include \$350,000 for an anatomy lab, \$88,000 for equipment, and money to hire a full-time professor. Approximately \$365,000 would be first-year program costs, including a one-time library acquisition budget of \$65,000.

Assuming a three percent increase at the University of Washington and a six percent increase at Creighton, the shortfall by the year 2000 would be approximately \$1.2 million. At full

implementation, UW would need almost \$2 million in added funds for the FY 2001 and 2002 biennium.

If UW was to continue with the Creighton University program and not participate in WAMI, with a continuation of 10 students per year, UW would require \$600,000 to stay with Creighton until the year 2002.

Trustee Ritthaler noted that she had spoken with doctors who had only positive things to say about WAMI. Trustee Jorgensen said that one of the most important decisions the board makes is starting new programs, and that unless WAMI was identified as a state priority, funded outside UW's block grant, budget cuts would have to be made to offset the costs.

Trustee Harris said there was no question about the benefit to the state, but he and other trustees were especially concerned about funding WAMI.

President Roark said he would not support WAMI if it had to be a UW supported and funded entity. The production of physicians and medical services to Wyoming is a state responsibility. President Roark said he would share the full set of figures with the appropriations committee and the Governor so that everyone is aware of the scope of the project.

Trustee Saunders noted that residency oversight of the medical school would make a difference in the quality of the residence pool. Assuming that 30 percent is brought back the state, and if the research base increases, the cost margin between Creighton and WAMI is narrowed.

The Governor's task force on education, as well as physicians across the state, have expressed support of the WAMI program.

President Roark suggested three possible ways to fund WAMI: 1) UW could submit a \$750,000 expanded budget to the legislature, 2) present it as a stand-alone bill, or 3) the Governor

could be asked to support it as a separate bill. Trustee Hammons noted that if it was to be submitted

as part of an expanded budget, it would come before the Trustees at the August 18-19, 1995 meeting.

UW's budget must be in the Governor's office by September 2.

Former UW Trustee and state legislator Win Hickey attended the committee meeting and

spoke in favor of WAMI. She suggested approaching the legislature with a firm stance, saying it is

best for UW and therefore best for the state.

Trustee Kepler said he would be interested in discussion as to making WAMI an action item,

and asked for additional cost figures before the full board meeting on Thursday.

During the full board meeting, Trustee Kepler moved that UW, through President Roark,

recommend an endorsement of WAMI. As part of the motion, Trustee Kepler said that in order for

UW to go forward, everyone at the government level must understand the costs involved and

demonstrate support for WAMI. Trustee Harris seconded the motion. Trustee Jorgensen suggested

that a specific proposal indicating benefits be presented to the Trustees at the next meeting as an

item for action. Trustee Hammons noted that Trustees would be prepared to go ahead with WAMI

with the understanding that it is a long-range funding commitment. After further discussion, Trustee

Kepler proposed an amendment to provide that WAMI will be presented in the budget as separate

from UW's block grant. Trustee Jorgensen moved and Trustee Harris seconded an amendment that

WAMI be presented in the budget as separate from UW's block grant. The motion carried. On a call

for the question, a vote on the amended motion passed.

Progress Report on Advising

A progress report on advising was presented to Trustees as an item for information. Provost

Karnig said that as a result of the Trustees' request, an instrument to effectively evaluate advisement

had been prepared. Provost Karnig provided Trustees with a draft of a common set of advising

questions. Students would go to their advisor, get advising for coursework, and then would be

requested to submit the completed form in order to register.

Trustee Catchpole asked for Trustee Krone's response to the draft. Trustee Krone said that

he had attended the deans' meetings when the questionnaire was being developed, and that he was

satisfied. Provost Karnig will work with others to develop a set of questions for graduate students.

Consistent with Trustee requests, the provost said he would ask each college to employ the advising

questionnaire every semester. After one year of experience, he said we could reevaluate the

frequency of use.

Trustee Ritthaler suggested that there be room for written comments, which Provost Karnig

said would be provided.

Provost Karnig asked Trustees to review the advising questions and make any suggestions

for change. He will share it with the faculty this fall.

BUDGET COMMITTEE

President Saunders called on Chairman Jorgensen for a report from the Budget Committee meeting

held on July 13, 1995. Committee members Jorgensen, Kail, and True attended the meeting, along

with other Trustees and University staff. Based on the committee meeting, the following

recommendations and reports were presented to the full Board.

Approval of Contracts and Grants, Gifts and Scholarships

It was moved by Trustee Jorgensen, seconded by Trustee Kirk, and carried that the Trustees of the University of Wyoming accept contracts and grants in the amount of \$5,037,933

for the period April 18, 1995 through June 30, 1995, and gifts and scholarships in the amount of \$185,545.43 for the period April 1, 1995 through May 31, 1995.

Trustees requested that future reports include charts on contracts and grants/ gifts and scholarships so that comparisons can be made with earlier totals.

Internal Audit Activity Conducted in Accordance with the Audit Plan for the Period April 1, 1995 to June 22, 1995

A report prepared by Van Jacobson, on the internal audit activity for the period April 1, 1995 through June 22, 1995, conducted in accordance with the audit plan, was presented to the Budget Committee.

Internal Auditor's Report on Status of Tuition Waivers in the College of Education/ Modification of Supervising Teaching Tuition/Fee Waiver Program

A proposal to modify the current supervising teacher tuition/fee waiver program was presented to the Trustees as an item for information.

The new program, rather than awarding tuition/fee waivers, would establish a flat dollar value to be awarded school districts for students participating in each practicum experience supervised by district personnel.

The district would subsequently distribute funding received from UW's "supervising teacher grants" to district personnel. These individuals would use the grant funds to cover tuition and mandatory fees for either continuing professional education or degree programs offered through the University of Wyoming.

Details on the proposed supervising teacher grants program were provided to Trustees.

Internal auditor Van Jacobson reported that he is currently involved in working out the details of

the implementation process of the proposed program. The item will be brought forward to Trustees for

action at their August 18-19, 1995 meeting.

Trustee Hammons asked that a report be prepared after tuition waivers are redeemed, and

suggested a follow-up report to the new system to determine whether further review is needed.

Half-Tuition Policy

Trustees were provided information on a proposed reduction in tuition and mandatory fees for off-

campus courses when instructional costs are defrayed by the district. The item will be returned for action

at the August 18-19, 1995 meeting of the Trustees.

Trustee Resolution 1995-1

It was moved by Trustee Hammons, and seconded by unanimous consent of all the Trustees that the following resolution be approved:

"Our thanks to the 117 employees leaving UW under the state's early retirement program.

Collectively, these outstanding individuals have given centuries of their best to UW and Wyoming. They personify the highest ideals of teaching, research, and public service. Through decades of good times and bad, they provided continuity, stability, and direction. Their careers speak to their commitment. Their good works are manifest in the lives of generations of students and their families. Their singular dedication has advanced a strong UW to the threshold of the 21st century.

It is with heartfelt gratitude and a sense of sadness that the University of Wyoming Trustees acknowledge the retirement of these remarkable men and women. Words cannot describe adequately the lengths to which they have gone to foster UW nor the depths to which their lives have touched the lives of others. Both UW and the state are better because of them. They truly made a positive difference, and they will be missed.

They go with our best wishes and profound thanks for jobs well done."

Trustee Jorgensen moved that Trustee Hammons be appointed chair, and Frosty Kepler serve on a subcommittee to determine how to best release the resolution to the news media. The motion was seconded by Trustee Harris and carried.

Retirements with Specially Designated Emeritus or Retired Status

Trustee Regulations regarding Trustee-designated <u>emeritus</u> or <u>retired</u> status relate to longevity and years of service. The retirees listed below qualify for participation in the early retirement program, but do not qualify for Board-designated <u>emeritus</u> or <u>retired</u> status because (a) they do not have 15 years of continuous service and have reached age 60 or (b) they have not completed 25 years of service. Further, many universities award <u>emeritus</u> or <u>retired</u> status based upon quality of service.

Based on a recommendation from the Personnel Committee, it was moved by Trustee Kail, seconded by Trustee Harris, and carried that the individuals listed below who have given distinguished service to the institution be specially designated emeritus or retired effective on their

retirement date. Individuals receiving such special designation shall qualify for the personal recognition but not for financial benefits customarily associated with Board-designated retirement status. Furthermore, those retirees designated with an asterisk (*) received the President's approval for an extension of early retirement beyond June 30, 1995. Trustee approval of these individuals will include ratification of the extensions.

PHYSICAL PLANT AND EQUIPMENT COMMITTEE

President Saunders called on Chairman Kinnaman for a report from the Physical Plant and Equipment Committee meeting held on July 12, 1995. Committee members Kinnaman, Harris, Jorgensen, Kepler, and Meyer attended the committee meeting, along with other Trustees and University personnel. Based on the committee meeting, the following recommendations and reports were presented to the full Board.

Livestock Teaching Arena

Bids for the construction of the Animal Science Teaching Arena are scheduled to be let in mid-August 1995, and the contract to be awarded the first half of September, 1995.

The project will include Phase 1 of the Animal Science Teaching Arena. Phase 1 is a building shell approximately 171 feet by 280 feet with lighting, minimal heating, animal wash racks and minimal restrooms.

The estimated total project costs, excluding operation and maintenance funding, is \$1,040,000. The budget plan to provide for operation and maintenance expense was approved by the Board of Trustees in the January, 1995 meeting.

Based on a recommendation from the Physical Plant and Equipment Committee, it was moved by Trustee Kinnaman, seconded by Trustee Harris, and carried that the Executive Committee of the Trustees and the Physical Plant and Equipment Committee be authorized to award the contract for construction of the Animal Science Teaching Arena, subject to ratification by the Board at the next regular meeting. Trustee Kepler abstained from voting due to a conflict of interest.

Meridian Oil - Paid-Up Oil and Gas Lease

By virtue of the Constance C. Spears estate, the University acquired 3.64 net acres of mineral rights in the SE 1/4 Section 31, Township 10 North, Range 20 West, Washita County, Oklahoma. Meridian Oil has decided to drill a new well, Cletus Pete #1-31 on this particular 1/4 Section. Compensation to UW would be a three year paid up lease in the amount of \$917.28 (3.64 acres x \$250.00 per acre bonus plus paid-up rental of \$1.00 per acre per year for two years). Should the well become a producer Meridian would pay a 3/16 royalty.

During the committee meeting, Trustee True indicated that he had the lease examined, and that it was probably a satisfactory offer. It was suggested that the royalty could be expanded to some degree, possibly as much as 20 percent. It was recommended

during the committee meeting to amend the lease to provide that it be approved subject to

Dan Baccari's negotiation with Meridian Oil in an attempt to get a 20 percent royalty.

However, during the full board meeting, it was moved by Trustee Kinnaman, and seconded

by Trustee Jorgensen that the lease be approved as presented to the Trustees in the Trustees'

report. The motion carried.

Progress Report and Change Orders

Electrical Engineering Grant

an opportunity to learn installation techniques for photovoltaics and expose students and the

public to alternative energy sources.

Portable panels would be installed on the roof of the engineering building, the

Trustee Kepler distributed a fund raising report through June 30, 1995, an update on

approved projects, and an update on capital projects to the Development Committee.

Meeting with Foundation Board

Trustees were reminded that they were scheduled to attend a meeting with the University of

Wyoming Foundation Board of Directors on Friday, July 14. At that time, a presentation will be

made by John Glier of Grenzebach, Glier and Associates, consultants for the upcoming fund-raising

campaign. Trustees were advised to meet with the consultants before ratifying a list of University

fund-raising priorities.

Vice President Simpson spoke to the committee, saying he was excited about the upcoming

campaign. He said a joint meeting of the Foundation Board and Trustees would help set precedents,

determine the commitment level, and bring about discipline in the campaign. Vice President

Simpson said it was a way to help control UW's destiny.

COMMITTEE OF THE WHOLE

The Committee of the Whole met on Wednesday, July 13, 1995. The following items were

discussed:

Environmental Simulation Facility

President Roark said that planning had been completed for the Environmental Simulation

Facility, and the project was now at a point where it was necessary to have a business plan in order

to pursue matching funding. A subcommittee of the Environmental Simulation Facility Planning Committee was appointed, which included Trustee Jorgensen, UW personnel, and persons outside the University, to develop a business plan for the operation of the proposed Environmental Simulation Facility. The business plan was to address both research activities and the cost of operation and maintenance of the facility. It was understood that the plan would address and meet the Trustee requirements for approval of the facility and that President Roark and the Trustees would have to approve the plan before the University proceeded with further development and planning for the Environmental Simulation Facility.

The business plan was completed, analyzed by vice presidents Baccari and Gern, and sent to Trustees on June 30, 1995. President Roark said it was with no great enthusiasm that he was recommending to the Trustees that the proposed Environmental Simulation Facility project be cancelled. He said he realized that a lot of work had gone into the project already, and that hopes and dreams would be shattered. However, he could not support it because UW could not afford to operate and maintain the facility.

President Roark said he had received a letter signed by the principal investigators disagreeing with his decision, and he would ask Mr. Baccari and Dr. Gern to respond to their points. However, President Roark's recommendation had not changed. President Roark noted that he had discussed the project with the Governor, and the Governor had asked that UW look at the possibility of scaling down the project. However, fixed costs associated with the project prevented a large decrease in costs. The Governor had also suggested that STEA be contacted to see if they had a mechanism or interest in subsidizing the project. STEA officials did not show an interest in pursuing the project.

During the business meeting, it was moved by Trustee Kepler, seconded by Trustee Jorgensen, and carried that the project be cancelled as recommended by President Roark. Trustee True abstained from voting because of a personal conflict, as did Trustee Ritthaler because of her

mixed feelings about the project.

President Roark noted that UW needs to provide a draft agency strategic plan to the Governor's office by July 17, 1995. UW has until September to develop the outcome portion of the plan. The final report will need to be reviewed annually to determine whether it continues to be appropriate.

During the committee meeting on Wednesday, Trustees raised concerns about the differences between the draft agency strategic plan and the Trustees' goals document finalized earlier this year, which focused on long-range planning. Because of those concerns, a motion was made during the committee meeting to defer further discussion until the next morning.

During the business meeting, Trustee Hammons stated that she had met with Vern Shelton about specific areas of concern, and that members of the administration were willing to meet with an ad hoc committee of Trustees following the business meeting. As the document is revised, it can be sent to the full board again. The draft document will be sent to the Governor's office on July 17th and will be further refined during the summer. It was moved by Trustee Harris that UW's goals and strategies for 1995 as prepared be submitted to the Governor's office and as may be amended by an ad hoc committee chaired by Trustee Hammons, and that the same be submitted as a draft copy. The

motion was seconded by Trustee Kepler. It was further recommended by President Saunders that the draft language be as explicit as possible in terms of UW's goals as it goes forward in draft form.

Salary Increases

It was moved by Trustee Kepler that the salaries of President Terry P. Roark and Van Jacobsen, internal auditor, be increased by three percent, effective July 1, 1995. This is consistent with that approved earlier for faculty and staff. The motion was seconded by Trustee Kirk and carried.

NEW BUSINESS

President Saunders read the following citation for Betty Long, who was awarded the Trustees' Award of Merit:

"Betty Long is one of UW's unsung heroines, a woman whose work often has gone unnoticed, yet whose actions have benefitted many.

Her institutional memory, coupled with her innate sense for equity, have buttressed University decision-making over four decades. Many times during their meetings Trustees have turned to Betty to set the record straight on precise points discussed previously or to ensure that the wording of convoluted motions will later appear in an unambiguous form in the official minutes. With a few words, Betty has the ability to recall for everyone what transpired previously. With a soft smile and slight nod, she gives assurance that when the minutes are transcribed, intent will prevail over verbal meandering.

It is with mixed feelings that the Trustees of the University of Wyoming acknowledge the retirement of Betty Long. On the one hand, there is pleasure in knowing that Betty is embarking upon an exciting new phase in her life, a time of new venues and new experiences. On the other hand, there is sadness knowing that at future meetings Betty won't be on the sidelines.

In recognition of her consistency, and with profound appreciation for friendships shared, the Trustees of the University of Wyoming are pleased to present to Betty Long their highest
