## **Primary Lead Program Application**

Project SCOPE (Supporting Children of the Opioid Epidemic) is a nationwide initiative to train interdisciplinary teams in high priority states on evidence-based practices in screening, monitoring and interdisciplinary care for children impacted by Neonatal Abstinence Syndrome (NAS), trauma, or related exposure. This initiative builds interdisciplinary provider capacity and closes gaps in access and delivery of quality education, treatment, and support services for young children aged 0 – 5 and families.

This National Initiative builds upon an effective model (ECHO-SCOPE) developed as a result of a 2018-2019 pilot supported by the Administration on Intellectual and Developmental Disabilities (AIDD) through the Association of University Centers on Disabilities (AUCD). The purpose of this project is to build nationwide provider capacity and confidence in applying evidence-based practices in serving children and families impacted by opioid use.

The initiative will support implementation of the model in 16 states over the course of three years, 2019-2022. Sites will participate in monthly meetings to build a national community of practice with other Primary Lead Programs to ensure fidelity to the model and share resources in order to build best and promising practices for this population.

Sites will be required to designate a Primary Lead Program located at an UCEDD or LEND to support the implementation of the model and will be required to:

- Ensure statewide interagency, interdisciplinary involvement throughout the duration of project
- Attend virtual orientation session to Project-SCOPE
- Attend a two-day, in-person ECHO immersion training
- Attend an in-person and/or virtual strategic planning session for the Primary Lead Program and their identified interdisciplinary state teams in order to finalize implementation strategy and launch the ECHO-SCOPE (if sites opt for an in person strategic plan it will be in conjunction with the ECHO immersion training)
- Implement ECHO-SCOPE curriculum within their own states

Primary Lead Programs will receive a stipend in order to support costs associated with the implementation of ECHO-SCOPE in their respective states.

- \$5,000 to support associated costs related to this initiative
- \$7,500 to support the Primary Lead Program's ECHO-SCOPE implementation, including incentives to ECHO-SCOPE participants that participate in the questionnaire component of the implementation (pre/posttest), and honorarium fees for speakers
- \$5,000 for every subsequent ECHO-SCOPE implementation

Priority will be given to states highly impacted by the opioid epidemic.
