Increasing Education on Advance Directive Use for End of Life Care Planning in Thermopolis, Wyoming

Purpose

 This project aims to increase public knowledge of Advance Directives (AD) and the importance of planning for end of life care.



Background

- Thermopolis, WY is a rural town in Hot Springs County which serves a population of less than 5,000.
- Thermopolis is a large retirement community due to the mineral springs in Hot Springs State Park.
- Hot Springs County has a very large elder population.
 - HSC: 23% of residents are age 65 or older.
 - Wyoming: 13.5% of the population are age 65 or older.
- Due to the high elder population and the coinciding increase in chronic illness, end of life care planning is an enormously important topic to address.
- From interactions with community members it became apparent that there was a lack of knowledge about AD and reasons why they should be completed.

Methods

- A literature review was used to identify evidence based methods to increase AD education.
 - A multidimensional approach that included an interactive session in addition to educational handouts was shown to increase AD knowledge.
 - Having counseling services available to answer questions increased AD completion.
- Community partners with established AD training and active participation with the elderly population were identified.
 - Hot Springs County Senior Citizen Center (HSCSCC)
 - The Wyoming Pioneer Home for Assisted Living (WPH)
- A community health project was proposed to the partners that would include an interactive oral presentation, educational handouts, AD forms and to establish a counseling service.


Results

- A presentation with a question and answer session was given at HSCSCC.
 - Approximately 55 adults attended the presentation including Senior Center Staff and elder community members.
- An educational brochure and packet on AD were given to attendees and instructed to remain available at HSCSCC and the Red Rock Family Clinic.
 - The handouts contained information on:
 - Wyoming specific AD.
 - Reasons why AD are important.
 - How to complete AD.
 - Who to contact with questions.
- HSCSCC and WPH provided AD packets containing further information and forms.
- The associate care coordinator at HSCSCC agreed to become the established counseling provider.

Discussion

- The project successfully increased public education on AD use for end of life care planning. Attendees of the presentation appeared to be very enthusiastic about learning more.
- The established counseling service is this projects greatest strength. This service is expected to increase AD completion.
- The most difficult aspect of the project is to increase education for all adults in Thermopolis.
- Hopefully through elder education, discussions will occur with family members to increase interest in AD and end of life care.
- End of life care planning is incredibly important and promoting the use of AD is a great way to improve public knowledge.
