The need for professionals with expertise in dementia care is growing rapidly as the prevalence of dementia continues to increase worldwide. In response, the University of Wyoming is offering a Dementia Care Certificate for healthcare professionals working with individuals with dementia. The certificate is an online self-paced program designed to fit within the healthcare professional's busy schedule. The modules are previously recorded WyGEC/WyCOA workshops, online trainings, and webinars that were taught by experts in their field.

The WyCOA Dementia Care Certificate is a convenient, easily assessable program that recognizes individuals for learning quality dementia care practices and knowledge.

The Dementia Care Certificate is offered through the University of Wyoming Center on Aging. The certificate is designed for professional direct care providers of older adults across care settings. The goal of the certificate is to increase providers knowledge of dementia and to enhance confidence in caring for people with dementia.

\*The total number of continuing education credit hours varies depending on the modules selected. This is a self-paced program. All content, quizzes and evaluations are provided online.

### **TO RECEIVE YOUR CERTIFICATE:**

\*Choose the level you would like to complete. You can complete both levels if appropriate.

\***Completion of 10 online modules for each level.**

-4 required modules

-6 elective modules to be chosen from a list of approved electives.

*Note: this program is self-paced. Students can choose the order in which they complete the elective modules. However, each student must complete the four required modules first.*

\*Completion of accompanying quizzes with a score of 70% or better

\*Completion of a program evaluation (this evaluation form will be available electronically upon completion of each level).

\*You must complete all requirements within 4 months and have view times matching the length of the videos. Modules may be viewed repeatedly, however credit is only given once.

\* You will received your certificate 4-6 weeks after completion of the program.
