

## University Conference Group Behavioral Agreement

All conference guests (adults & youths) are expected to comply with any and all applicable University regulations and policies, all applicable local, state, and federal laws. Failure to comply with any of the above may result in the individual being sent home and possible criminal penalties (if applicable). User Staff are expected to take appropriate measure to respond and resolve violations of any of these rules, including calling the University Police. **If conference guests fail to comply with these behavioral standards or laws, including but not limited to those listed below, the guests or staff members may be removed from the residence halls and may also cause the entire event to be terminated.**

### 1. Alcohol

- A. The use, possession and distribution of alcoholic beverages is not allowed in the Residence Halls or Dining Room. Conference staff and guests, even if over 21, are not authorized to drink alcoholic beverages in the Residence Halls.
- B. Public intoxication is prohibited. Further, it is expected that staff and guests will not be returning to the Hall intoxicated.

**2. Assisting with a rule violation.** Assisting in the violation of any applicable University regulation, policy, local, state, and/or federal law is prohibited.

**3. Damage, loss, vandalism, or tampering with personal or university property.** Damage, vandalism, or tampering with the property of the University or another resident is prohibited. This includes unauthorized moving and/or modification of University property.

### 4. Dining Room regulations.

- A. Conference Meal card is required for entrance to the dining room. Dining room privileges are non-transferable. A card used by anyone other than owner will be confiscated.
- B. One entrée per time through serving lines. Unlimited visits to serving lines during visit.
- C. Throwing food or objects in the dining room is prohibited. Causing food to be thrown is also prohibited.
- D. Large equipment bags (e.g. football helmets and shoulder pads) must be stored in guest room and not in Dining Center.
- E. Water bottles of any kind, mugs, or any other beverage containers, are not allowed in Dining Room.
- F. Shirts, shoes and appropriate clothing must be worn at all times in Dining Room.
- G. Food must be consumed within the Dining Room. Food is not allowed outside of the Dining Room.
- H. Plates, silverware, and other Dining Services property must remain within the facility; removal of any of these items will be considered theft.
- I. Students must take trays, dishes and trash to the designated area when finished dining.
- J. Entrance into the kitchens, storerooms, loading dock, and areas used to prepare food is restricted to authorized persons.

### 5. Disorderly conduct.

- A. Study/quiet hours are Sunday-Saturday 8 pm-8 am. Courtesy hours are enforced at all other times. Courtesy hours provide that the residents/staff reserve the right to ask that any noise that is disruptive to another individual must be discontinued at any time.

- B. Disruption or obstruction of conference meetings, dining center operations, other University or project activities, including its educational or other functions on- or off-campus, or other authorized activities on University premises is prohibited.
- C. Disorderly conduct that disrupts the operations of the University leading or inciting others in such activities that disrupt those operations or infringe upon the rights of members of others is prohibited.
- D. Actions which have an adverse impact on the University and RLDS Summer Conference community, its members, and/or the pursuit of its objectives, regardless of where such conduct may occur is prohibited.

**6. Failures to identify, cooperate, or comply.** Failure to identify oneself upon request or furnishing false identification is prohibited. Willfully or knowingly lying or falsifying information to University personnel, whether in your own behalf or for another person is prohibited.

**7. Harassment.** Harassment of other individuals will not be tolerated and is prohibited.

**8. Illegal drugs.** Use, possession, or distribution of any drugs or other controlled substances is prohibited.

**9. Offenses against Property.** Making or communicating false alarms or threats, tampering with fire extinguishers, the intentional mixture of harmful or hazardous biological/chemical materials for purposes other than those under the supervision of a University faculty/staff member is prohibited.

**10. Pets/Animals.** Animals are not permitted in residence halls.

**11. Posting of signs, information, banner.** Banners, signs, picture and other items may not be displayed on the room's window and/or interior or exterior of the building.

**12. Bikes, skateboards, rollerblades, skates, or related items.** These items may not be used inside residence hall, Washakie Center or in Dining Room. Outdoor use near residence halls must be consistent with university policies and guidelines.

**13. Combination/Keys.** Tampering with any residence hall lock and/or "propping" open doors are prohibited. Duplication of keys or misuse of combinations to any residence hall building, room, mailbox or office is prohibited.

**14. Climbing:** Climbing or attempting to climb, the exterior or interior of buildings or halls or through room windows, is prohibited.

**15. Combustible substance:** Bringing into or storing petroleum distillates or containers (empty or full) such as fuels, solvents, or other highly combustible substance in the residence halls is prohibited.

**16. Elevators:** Tampering with hall elevators, including but not limited to misuses of emergency stop, alarms, prying doors open, or causing elevators to jam is prohibited.

**17. Fire safety equipment, evacuation, and false alarms:** Tampering, damage, or misuse of fire safety equipment, alarms, extinguishers, exit signs, and smoke detectors is not permitted. Falsely reporting, setting, or causing a false alarm is prohibited.

**18. Flammable material:** Burning of any substances in the residence halls is prohibited. Open flames or exposed element appliances (such as hotplates) are prohibited. The use of extension cords or multi-pug outlet adapters is prohibited. (UA-approved power strips are recommended). Halogen lamps are not

permitted due to the high incidence of fire safety concerns related to these lamps. Storing, transporting, or discharging fireworks or any kind is prohibited. Non-potted trees are prohibited.

**19. Objects thrown to and from windows:** Throwing, dropping, or propelling any object (including liquids) from residence hall windows is prohibited.

**20. Weapons:** Firearms, weapons, ammunition, and explosives are not permitted in or around residence halls and dining rooms. Weapons included but are not limited to the following items: pellet guns, “BB” guns, airsoft type guns, sling-shots, knives (blades 3” or longer), blow guns, dart guns, bows, arrows, or other devices that could cause injury may not be stored or used in residence halls or dining rooms.

**21. Smoking.** Smoking and/or vaping is prohibited in all residence hall and dining areas.

**22. Unauthorized entry.**

- A. Building entry is restricted to residents of that facility. Entering through locked side doors after security hours or attempting to break and enter is prohibited. Entry onto other floors within the conference groups’ assigned residence hall is prohibited.
- B. Unauthorized use of a key, combination, or other method to gain entry to locked facilities without University authorization is prohibited.

**23. Unauthorized room changes.** Conference guests are expected to reside in assigned rooms. Unauthorized room changes are prohibited. Please contact the front desk if you need to change rooms.

By signing below I agree to abide by the above rules. I will treat all conferences staff, participants and all University staff with respect and I will follow all directions and requests given by these personnel. If I fail to comply with this code of conduct I fully understand that I will be removed from the residence halls and may also cause my group to be removed as well.
