1. Faculty

Any tenured member of the University faculty may apply for a sabbatical leave for the purpose of increasing the recipient's professional competence and usefulness to the University. Sabbatical leave time may be used for research, writing or study at a place of the recipient's choosing. University personnel holding tenured faculty rank whose duties are primarily administrative are also eligible for sabbatical leaves. A minimum of six years of academic service at the University must precede each period of sabbatical leave, although no right accrues automatically through lapse of time.

Sabbatical leaves are not ordinarily available for the purpose of obtaining an advanced degree. A faculty member who fails to return to the University for at least one academic year immediately following a sabbatical leave is obligated to repay the amount of compensation received from the University during the leave. Leaves for a full contract year are compensated at a rate equal to 60 percent of the employee's annual salary; leaves for a half-contract year are compensated at the employee's existing rate for the period.

In each case, the teaching responsibilities of faculty on sabbatical leave will be assumed by other instructors, and there will be no reduction in number of courses offered as a result of the sabbatical leave. Requests for sabbatical leave undergo review by the appropriate department head and dean. They are also reviewed by the Office of Academic Affairs.

This year, a total of 31 faculty members and academic professionals requested sabbatical or professional development leaves. Academic Affairs screened these requests and forwarded 31 requests with positive recommendations.

External funding is provided by: the National Science Foundation and West Virginia University, with logistical support by Tulane University, University of Connecticut, Harvard University, and the USDA-ARS Systematic Entomology Laboratory (at the U.S. National Museum of Natural History, Washington, D.C.). Expected results include scientific publications, student recruitment, opportunities for future grants, experience that will improve teaching of U.W. classes, and improved specimen research collections at the U.W. Insect Museum.

Strauss, Sarah Associate Professor Academic Year 2005-2006

Professor Strauss will complete a book based on eight years of UW and NSF-funded research on the changing fate of water resources in a Swiss alpine valley. This book project addresses what can be called the "social life of water" in Leukerbad, Switzerland, as a way of helping local people to understand the context of their own decisions about water resources, and providing a comparative model for international scientists and policymakers to view the relationship between natural resource constraints and local community beliefs, behaviors, and values as expressed through all facets of their social and cultural lives.

Denney, Colleen J. Associate Professor Academic Year 2005-2006

Professor Denney will conduct travel, research and writing for an art historical book, "From Private Study to Public Stage: Victorian Scandals and Women's Modern Identity Formations." The book examines the 19th-century obsession with the making of the public self, with a focus on professional women who, through portraits (in painted, photographic, and print media), engage in a modernist dialogue about a woman's public visual presence.

Gladney, George A. Associate Professor Academic Year 2005-2006

Professor Gladney seeks a nine-month Fulbright Scholars Program assignment in Poland, Latvia, Hungary, or Italy. He is specifically targeting the Center for Social Studies in Warsaw, Poland, to teach and do research related to the study of mass communication and society. He will gather first-hand knowledge to help him design and implement a new course in international communication and global media at UW, research universal (global) values related to media ethics, and help implement the new Vinci Program in Media Ethics sponsored by the European Union.

Belanger, Kelly R. Associate Professor Spring 2006

Professor Belanger will initiate a new direction for her research by 1) studying recent scholarship and current directions in rhetorical criticism, 2) analyzing the discourse surrounding the "Title IX Wars," 3) assessing through interviews and textual analyses the contributions to feminist rhetorical traditions of post Title IX era athletes who write about sports and, conversely, the impact of the Title IX debates on athletes' published writing, and 4) visiting the University of Minnesota to consult with two internationally recognized scholars on Title IX and feminist rhetoric.

Loffreda, Beth A. Associate Professor Fall 2005

Professor Loffreda will work on her manuscript, "Making a World of Books," a study of contemporary fiction from the point of view of those who make their living from, and for, literature. How do they-the editors, the creative writing professors, the agents, the publishers, the marketers, the reviewers-cultivate the landscape of contemporary fiction, and what writers and trends emerge more clearly into the light when they're heard? Literature scholars rarely speak to, or study the world of, those who oversee the business of literature. Professor Loffreda's goal will be to fill in that large scholarly gap, and to offer a rich portrayal of the current state of American writing.

Baker, William L. Professor Academic Year 2005-2006

Professor Baker will draft a book manuscript on Ecology and Management of Fire in Rocky Mountain Landscapes. In the process of completing this work, he will visit universities and agency offices, and travel throughout the Rocky Mountains gathering data and meeting with other researchers.

Department of Geology & Geophysics

Eggleston, Carrick M. Associate Professor Academic Year 2005-2006

Professor Eggleston will study the role of certain proteins in transferring electrons to oxide minerals at the Laboratory for Photonics and Interfaces at the Swiss Federal Institute of Technology in Lausanne, Switzerland. This fundamental process has applications in new photovoltaic technologies as well as in understanding how certain microorganisms interact with minerals to drive geochemical processes. This project supports and enhances a change in Dr. Eggleston's research direction toward life-science aspects of geoscience that has already begun to result in extramural grant funding, and is consistent with several aspects of the 2004-2009 Academic Plan with regard to interdisciplinary teaching and research.

Bantjes, Adrian A. Associate Professor Fall 2005

Professor Bantjes plans to complete a well-advanced book manuscript entitled Idolatry and Iconoclasm in Revolutionary Mexico: Popular Religion and Cultural Revolution, 1910-40," a study of the Mexican revolutionary elite's iconoclastic de-Christianization campaigns. He will present his findings at an international workshop at Queen's University, Belfast (U.K.). By the end of his leave, Dr. Bantjes will present a book proposal to leading academic presses in the field of Latin American Studies. He expects to submit the completed manuscript for publication by Spring, 2006.

Professor Howell will collaborate with research groups at the Lunar & Planetary Laboratory at the University of Arizona primarily in two general areas. The first is an extension of ongoing modeling of volcanism on Jupiter's moon Io. The team responsible for the visible-wavelength imager on the Galileo spacecraft recently orbiting Jupiter is based there, and this collaboration will allow incorporation of that data set in more detailed models. The second area is the modeling of recently discovered X-Ray emission from the Galilean satellites of Jupiter, another area where Arizona researchers have special expertise.

Professor Lovvorn plans to do his sabbatical at the National Center for Ecological Analysis and Synthesis, an NSF-supported facility at the University of California at Santa Barbara. The center's goal is to promote integration of data from multiple disciplines to yield new ecological insights useful in applied decision-making, via collaboration and modeling. Jim will work with a large data set collected in one of his nearby coastal study areas to model the energy balance of seabirds feeding on kill prey, whose distribution changes in time and space depending on oceanographic processes. The resulting model will be used to evaluate the potential impact on seabirds of being excluded from key feeding sites by clean-up activities during an oil spill.

Her goal is to develop a set of baseline data and procedures that will accurately inform our efforts and provide useful direction for our information literacy instruction program.

2. Academic Professionals

The purpose of professional development leave is to allow academic professionals to enhance their performance, to conduct special studies, or in some other way to undertake planned activities related in a substantial manner to the individual's role at the University.

To be eligible to apply for professional development leave, academic professionals must have been granted an extended-term contract. Initial requests may be submitted no earlier than the seventh year of academic service. If granted, the leave may be taken no earlier than the eighth year. Subsequent leaves must be preceded by a minimum of six additional years of academic service, although no right accrues automatically through lapse of time. Other conditions for professional development leave are generally those that apply to sabbatical leave for faculty.

An academic professional who fails to return to the University for at least one academic year immediately following a sabbatical leave is obligated to repay the amount of compensation received from the University during the period of his or her leave.
