## EXCELLENCE IN HIGHER EDUCATION AND CHALLENGE PROGRAM ENDOWMENTS

Tables on the following pages describe generally how each community college and the University of Wyoming are using the funds received from both the Excellence in Higher Education Endowment Program and the Endowment Challenge Programs.

## **EXCELLENCE IN HIGHER EDUCATION ENDOWMENT PROGRAM**

The Excellence in Higher Education Endowment Program was initiated in 2005 (`05 Laws, Ch. 190). In February, 2006, an initial endowment appropriation was made to each community college in the amount of \$306,259 and to the University of Wyoming in the amount of \$4,300,000. These funds are part of the endowment and only the interest received on these funds may be spent. Additionally, in July, 2006, a special appropriation from the Common School Permanent Fund Reserve Account (`06 Laws, Ch. 45) of \$200,000 was made to each community college and \$2,800,000 to the University of Wyoming. (Later, the University's amount was reduced to \$1,800,000 in `08 Laws, Ch. 48, Section 333.) This allowed each institution to begin hiring staff for the Excellence in Higher Education Program while the Endowment Accounts for each institution were being filled by the diversion of Federal Mineral Royalties. Now, as of April, 2008, the Endowment Accounts are full.

The community colleges and University of Wyoming are to use the endowment earnings "to establish endowed faculty positions and to acquire instructional and resource materials, classroom equipment and other resources necessary to support the work of endowed faculty" (W.S. 21-16-1202 and 1203). In October 2008, the higher education institutions reported their use of endowment funds in Fiscal Year 2008. **Table 1** summarizes how much each institution spent in that year and how they used the funds.

The final position is in accounting.

## COMMUNITY COLLEGE ENDOWMENT CHALLENGE PROGRAMS

The Wyoming Community College Endowment Challenge Fund was created in 2004 (`04 Laws, Ch. 117) and funded with a \$31.5 million appropriation from the General Fund which will allow an endowment of \$4.5 million in state funds (which are matched with private donations) for each community college. As detailed in **Table 2**, in 2007, 2008, and 2009, the Legislature has appropriated additional funding to community colleges that met previous matches.

**Table 3** illustrates information on the Wyoming Community College Endowment Challenge Fund. Using data from the State Treasurer's Office, it displays the actual amounts of state match money each college has received as of June 22, 2009. Each college only receives state matching funding once it has actually received the donation. However colleges also report on commitments, even if the college has not yet received the donation; these commitment amounts are included in Table 3. Finally, the table includes a short description of the intended use of the funds.

## University of Wyoming Endowment Challenge Programs

The University of Wyoming has three matching endowment challenge programs: Endowment Challenge Program, Academic Facilities Matching Program, and Athletics Matching Programs. The authorization for these programs is shown in **Table 4**. The University of Wyoming's Endowment Challenge Program began in 2001 (`01 Laws, Ch. 197) with an initial \$30 million General Fund appropriation in the standard budget, (`01 Laws, Ch. 139, Section 067, Footnote 2). As shown in Table 4, this program has received additional appropriations in recent years as the University has met prior matches.

The University of Wyoming Athletics Facility Matching Program was initiated in 2004 ('04 Laws, Ch. 61) with a \$10 million appropriation ('04 Laws, Ch. 95, Section 3, Subsection 067) from the General Fund. The Legislature in 2006 ('06 Laws, Ch. 70) added additional money to the Program by appropriating an additional \$6 million from the General Fund to continue the Athletics Facility Matching Program.

The University of Wyoming Academic Facilities Matching Program began in 2006 (`06 Laws, Ch. 70) with an initial appropriation of \$9 million from the General Fund. The Legislature added to this amount with a 2007 (`07 Laws, Ch. 136, Section 3, Subsection 067) appropriation of \$31.35 million which was designated for a number of projects. In 2008, the Legislature added an additional \$3 million (`08 Laws, Ch. 48, Section 3, Subsection 067). In 2009, the Legislature authorized the University to move certain funding that had been appropriated to academic facility matches for certain projects (`09 Laws, Ch. 159, Section 344). Of the \$6.25 million appropriation for labs and other facilities, the University may spend up to \$1.4 million to purchase a parking lot. Additionally, of the unexpended, unobligated portion of the \$20 million appropriation for the School of Energy Resources Facility:

- The University may use \$3 million from academic facilities for the athletic facilities challenge.
- ➤ Up to \$1,422,522 of the academic facility endowment authorization shall be credited to the University's block grant to replace funds spent to fund clean coal technology research.
- ➤ The balance may be used for the Endowment Challenge Matching Program. According to the Treasurer's Office, the University estimates that this will be approximately \$5.6 million.
