TOPPAN RARE BOOKS

The Toppan Rare Book Library had a productive and exciting year that saw success in many areas. These are noteworthy highlights:

FY 2024 Special Projects, Accessions. and the Ongoing Work

- Continued working on organizing Spec Coll collections and making sure that we have intellectual control over them. Includes reshelving books in a way that decreases the time spent looking for books
- Moving oversize books to one area of the stacks in Room 129 so that they are together
- Samuel Peeples collection transfer from manuscripts to Toppan; swapping processed Peeples with unprocessed Coe Deacc boxes in Room 114
- Working with Erin Shadrick, Accessioning Unit Supervisor, on moving any rare books material from Main Storage, room 111, to Toppan space
- Continuing to work with Processing regarding the transfer of rare books to Toppan
- Worked on reorganizing collections labeled under the catch-all "Spec Coll"
- In process—reorganizing the shelf arrangement of sub-collections in the book vault.
- Caught up with uploading catalog records to OCLC and Alma
- Moving the special materials from 4th floor cabinet to cabinet in main stacks
- During Summer 2025, we had a volunteer from the pre-ETS program work with us in Toppan on entering information from uncatalogued collections into spreadsheets for ease in cataloging.



University Archives

Report from the University Archivist & Historian

As the University Archivist & Historian, I am honored with the responsibility of ensuring the preservation of the university's history. I interact with departments across campus on a daily basis to make certain important documents are properly preserved and transferred to the American Heritage Center where they are organized and made available for researchers. As the university's historian, it is exciting to see what historical records are transferred to the archive and what stories can be told from the documents.

In addition to working with units across campus, as the university archivist I also interact with retired faculty to preserve their research, as well as members of public, including alumni, who wish to donate UW-related materials, including memorabilia, letter sweaters, photographs, yearbooks, and scrapbooks they cherished from their time at the university. Finally, I also interact with UW-related organizations to preserve their organizational records.

During the fiscal year, the AHC received records from a wide array of units. The list is long but a few include the Board of Trustees, the office of Academic Affairs, Office of General Counsel and Legal Services,



Department of Music, Molecular Biology, School of Energy Resources, the College of Business (including the contents of the building's 1960 time capsule after it was opened during a construction project), the College of Arts and Sciences, the College of Agriculture (including Cooperative Extension and Experiment Stations), ASUW, MEChA, Multicultural Affairs, University Libraries,

Faculty Senate, and the Department of Family and Consumer Science. Of the university employees, some of the collections received include materials from Charlotte Davis, who worked at the university for 34 years, first as the assistant dean of women and later as the associate director of Student Affairs; James Walsh, a librarian who researched the history of Wyoming place names; former president Philip Dubois; retired Law professor Debra Donahue; John Nutter, who was the director of Financial Aid and later was the assistant to the Dean of Students; material from the family of Frank Trelease, who was the Dean of the Law School from 1960-1971; retired Botany professor Greg Brown; material from the family of former Dean of Engineering Sam Hakes; Gary Franc, a former Plant Sciences professor; material from the family of William Mulloy, a former Anthropology professor known for his Easter Island research; Larry

Weatherford, a retired professor from the College of Business; and material from the family of former head basketball coach Jim Brandenburg. Aid and later was the assistant to the Dean of Students; material from the family of Frank Trelease, who was the Dean of the Law School from 1960-1971; retired Botany professor Greg Brown; material from the family of former Dean of Engineering Sam Hakes; Gary Franc, a former Plant Sciences professor; material from the family of William Mulloy, a former Anthropology professor known for his Easter Island research; Larry Weatherford, a retired professor from the College of Business; and material from the family of former head basketball coach Jim Brandenburg. Organizational records received include historical materials from the Alumni Association, Sigma Alpha Epsilon, Phi Delta Theta, the UW Symphony Association, and Golden Key National Honor Society. Some notable donations from alumni include materials related to UW

Summer Geology Field Camp, the Wyoming

Homemakers Association, scrapbooks of campus life dating back to the 1920s, 30s and 40; dance cards, and basketball memorabilia from the family of Milo Komenich who was a member of the 1943 national champion



basketball team, as well as additional papers related to his teammate Kenny Sailors.

These short lists of materials from colleges and departments, organizations, retired employees, and alumni highlight the diversity of UW-related collections at UW. Materials received cover the expanse of 100 years and range from heavy science to student activities, and from basketball history to administrative records. There is something for everybody at the AHC. As the university's historian, I continue to research the history of campus units, buildings and grounds, and people and events. Current projects include the history of the origin of Pistol Pete who first appeared live on campus in 1971; the history of the Department of Atmospheric Science with its roots dating back to the early 1960s; historical research about the Honors College that began as a program in 1958; ongoing buildings and grounds research; and I conducted an oral history audio interview project with long-time Athletic Department employee and radio voice Kevin McKinney. Finally, I coauthored a book with my colleague, Erin Shadrick, about the history of Bureau of Mines that later became known as the Western Research Institute (WRI), which celebrated its 100th anniversary on July 1, 2024.
