THE FLOYD E. DOMINY COLLECTION, Acc. #2129-81-05-26

Floyd E. Dominy (b. 1909) began his career with the federal government following graduation from the University of Wyoming in 1933, as County Extension Agent in Campbell County, Wyoming from 1934-1938. Following positions with the Agricultural Adjustment Administration, the Food Supply Division of the Office of the Coordinator of Inter-American Affairs in service as a Naval Reserve Officer, he began service with the U. S. Department of the Interior, Bureau of Reclamation as Land Settlement Specialist, Irrigation Division in 1946. From 1947-1950 he was Chief of the Allocations and Repayment Branch, Irrigation Division; from 1950-1953, Assistant Chief, Division of Irrigation; from 1953-1957, Chief, Division of Irrigation; from 1957-1958, Assistant Commissioner of the Bureau; from 1958-1959, Associate Commissioner of the Bureau, and from 1959-1969, served as Commissioner of the Bureau of Reclamation, first appointed by President Eisenhower, and continuing until his retirement in 1969. He is also the owner of a livestock and farm operation at his home in Virginia.

The majority of this collection is correspondence, professional files, speech files, and related information from his career with the Bureau of Reclamation, and other government service. In these files is information on all aspects of reclamation projects such as the Colorado River Storage Project, Columbia Basin Project, Missouri River Basin, Central Arizona Project, and many others. Most of the material in the collection is thermofax, carbon, or photocopied material, unless noted otherwise.

There are extensive photographs of Bridge and Marble Canyons, Rainbow Bridge, and Lake Powell, as well as portraits of Floyd Dominy, and photographs with other government officials, dignitaries, and other prominent individuals. Some films and audiotapes pertaining to the Bureau of Reclamation are also included.

In addition there are personal files, awards, certificates, and biographical materials concerning Floyd Dominy, and his family.
