The Wilma Soss Collection consists primarily of business files from her work as a stockholder rights activist, as president/chairman of the Federation of Women Shareholders in American Business, which she founded in 1947, a leader of the women's economic suffrage movement. Included are recordings and transcripts of her weekly radio program on consumer affairs, "Pocketbook News"/"Wilma Says", which was broadcast by NBC, from 1954-1980. Files of newspaper clippings, magazine articles, and correspondence detail the combined efforts of Wilma Soss, Lewis Gilbert, and John Gilbert to secure corporate democracy and shareholder rights.

There are correspondence files and newspaper articles from her early career as one of the first women public relations agents, as assistant to press agent Harry Reichenbach, as publicity consultant for International Silk Guild, Evans Products Co., The Budd Co., Saks, and other businesses.

Although the collection consists primarily of business files related to stockholder rights, there are also personal letters, photographs, biographical material, and partial manuscripts of autobiography.


