Biography

Arthur Gordon Rippey Jr. was a prominent Denver, Colorado businessman. He was the founder of Rippey, Henderson, Bucknum, and Company, a very successful advertising firm. During the course of his life, he was also a noted collector of antique automobiles and rare books.

Mr. Rippey was born to Arthur G. Rippey Sr. and Lillian Grace Rippey in Des Moines, Iowa on May 11, 1907. His father was a lawyer by profession. Arthur Jr. spent his childhood years in Des Moines and attended high school in Chicago, Illinois. During his formative years, he discovered his two lifelong interests: automobiles and literature. After graduating from high school, Rippey entered the University of Illinois in 1925, earning his B.A. in 1929.

After college, Rippey went to work for the Jamison Handy Organization, a maker of educational films. Starting as a script proofreader in the firm's Chicago office, he quickly rose through the ranks. By 1932, he was an account executive/writer in Jamison Handy's Detroit office.

While working in Detroit, Arthur Rippey met Helen Elizabeth Crabbs, the niece of Agnes Reid Tammen, wife of the co-founder of *The Denver Post*. They were married on January 28, 1933. The couple had three children: Cynthia (born 1934), Arthur Gordon III (born 1935), and Bruce Richard (born 1938).

Meanwhile, Rippey continued to advance in the promotional and instructional film business. In 1935, he became an editorial manager at the Detroit office of Audivision Incorporated, a New York City film maker. Two years later, he joined Associated Sales, a film making venture of the Cadillac Printing Company. Along with partners Donald Benedict and Genaro A. Florez, Rippey purchased Associated Sales in 1938 and renamed it Visual Training Corporation. During World War II, their firm produced training films for the U.S. Armed Forces.

In 1943, Rippey and his family relocated to Denver, in order to manage the late Agnes Reid Tammen's estate. Soon after his arrival, he established Arthur G. Rippey & Company Advertising Agency. Rippey was quickly joined by partners Gilbert Bucknum and Clair Henderson and renamed the firm Rippey, Henderson, Bucknum, and Company. The firm flourished and by the late 1950s, it was the largest advertising agency between Kansas City and the West Coast. It counted Coors, Safeway, U.S. National Bank, and other large companies among its clients. Arthur Rippey retired from the agency a wealthy man in 1966.

Pursuing his youthful enthusiasm for automobiles, Arthur Rippey was a well-known antique automobile collector for many years. He began collecting and restoring cars after World War II, starting with his father's 1934 Ford V-8 and 1922 Jewett. By 1953, Rippey's collection consisted of 20 cars, which included noteworthy vehicles such as a 1909 Cadillac Model 30 Touring Car, a 1910 Locomobile Speedster, and a 1922 Rolls-Royce Silver Ghost. In 1963, he established the Veteran Car Museum, which was Denver's first automobile museum. He was also an active member of several automobile organizations, including the Vintage Car Club of

America and the Mercedes-Benz Club of America. Rippey began to sell off his automobile collection during the late 1960s. In 1980, he sold the Veteran Car Museum and had sold off most of his collection by this time as well. He donated the papers of the Veteran Car Museum to the Denver Public Library.

In his retirement, Arthur Rippey was a notable collector of rare books. He collected original editions of Samuel Johnson and his biographer James Boswell, beginning in 1967. He also collected other 18th century volumes and the works of Aldous Huxley as well. While pursuing this hobby, Rippey founded the Johnson-Boswell Society of the Rocky Mountain Region and was a member of several literary clubs and societies in the United States and Great Britain. He also published the letters of Reverend Harry Chapell, an English friend and fellow literature enthusiast. Rippey traded his Huxley works to the University of Colorado in 1975. His Johnson-Boswell collection was sold to the McMaster University Library, a collector of these works, in 1985. Other rare books were donated to the University of Wyoming's American Heritage Center in 1997.

Arthur Rippey pursued many other interests besides his hobbies in his retirement. He was a financial contributor to the Republican Party. Rippey was also a longtime member of several professional and charitable organizations in Denver, including Rotary International and the Denver Public Library Foundation. He was also a member of the Old Baldy Club in Saratoga, Wyoming and had real estate interests in the Bahamas.

Series Description

The Arthur G. Rippey Papers are arranged into 6 series:

- Series I. Personal Files, 1918-1995. 4.0 cubic ft. (9 document boxes and 1 folder). Arranged alphabetically. Consists mostly of correspondence with individuals and organizations. Also contains his early personal correspondence, biographical materials, publicity photographs, speeches, and travel materials.
- Series II. Automobile Collection Files, 1941-1994. 3.0 cubic ft. (6 document boxes and 7 folders). Arranged alphabetically. An assortment of materials concerning Arthur Rippey's automobile collection and related activities. Contains individual files on several cars in his collection. Also includes correspondence with individuals and organizations, clippings, memorabilia, and photographs. Rippey's automobile-related speeches and a few files regarding the Veteran Car Museum are in this series as well.
- Series III. Book Collection Files, 1935-1995. 7.0 cubic ft. (15 document boxes and 6 folders). Arranged alphabetically. Files concerning Arthur Rippey's book collection and related activities. Includes correspondence with individuals and organizations. Also contains files regarding the collection itself and its eventual disposition.
- Series IV. Business Files, 1931-1994. 2.0 cubic ft. (4 document boxes and 4 folders). Arranged alphabetically. Files concerning Arthur Rippey's business activities. Contains material relating to Rippey's various residences. Also has a few of his pre-retirement professional files, consisting of a small amount of correspondence and a few speeches. Additional files regarding his membership in the Old Baldy Club and his post-retirement business interests in Rolls-Royce and Twymar International Limited are in this series as well.
- Series V. Political Files, 1962-1980s. 0.1 cubic feet (13 folders). Arranged alphabetically. Files concerning Arthur Rippey's contacts with various politicians. Consists of a small amount of correspondence, Christmas cards, post cards, photographs, and photo reproductions.
- Series VI. Oversized, 1940s-1980s. 0.9 cubic feet (1 F24 flat box). An assortment of oversized items relating to Arthur Rippey. Series includes a pencil sketch, a set of blueprints, a photograph, and a photo reproduction.

Scope and Content

The Arthur G. Rippey Papers, 1918-1995, include correspondence, legal documents, manuscripts, clippings, photographs, and other assorted items. These materials document the activities of Arthur G. Rippey, a prominent Denver advertising executive, antique automobile, collector, and rare book collector. This collection covers the span of Mr. Rippey's adult life, but its contents deal primarily with his post-retirement activities.

The Personal Files (Series I) document Arthur Rippey's life and activities on a personal level. The biographical materials and a small amount of the correspondence cover his early life and business career from his point of view. The rest of the correspondence extensively documents Rippey's life after his retirement. These documents reveal Mr. Rippey to be a man with a wide circle of friends and many interests besides automobiles and books. They also shed light on how he was affected by the events of his life.

The Automobile Collection Files (Series II) concern Arthur Rippey's hobby of collecting automobiles. Individual automobile files and some of the photographs identify the cars he owned and provide some information about their acquisition, restoration, maintenance, and disposition. Other photographs and memorabilia document Rippey's participation in automobile related activities. The correspondence in this series provides insights into his relationship with other auto enthusiasts and his standing within the car collecting community. The Veteran Car Museum files have a small amount of information about the operation of that institution.

The Book Collection Files (Series III) extensively document the development of Arthur Rippey's rare book collection. Consisting mostly of correspondence, these files provide much information about the contents of the collection and how and where he acquired his books. These documents also reveal much about his tastes in literature, particularly his enthusiasm for the original works of Samuel Johnson and James Boswell. These files show that he corresponded with a wide circle of other rare book collectors, book dealers, and scholars and was quite active within this particular community. Of particular interest are the documents regarding the disposition of his book collection.

The Business Files (Series IV) concern Arthur Rippey's professional career and post-retirement business dealings. There are only a few files from his professional career, consisting of a file from his stint at the Jamison Handy Organization and speeches from his career as an advertiser. His post-retirement files are more substantial, containing files regarding the construction and maintenance of his various residences in Colorado and Wyoming. They also include files regarding his membership in the Old Baldy Club and his business interests in Rolls-Royce Limited and Twymar International Limited (his real estate holdings in the Bahamas).

The Political Files (Series V) show Arthur Rippey to be politically conservative and a staunch supporter of the Republican Party. This series contains mostly memorabilia, including Christmas cards, photographs, and photo reproductions. There is a small amount of correspondence as well.

Oversized (Series VI) consists of individual items from throughout Arthur Rippey's adult life. The series includes a pencil sketched self-portrait of Joyce Aris, blueprints of his Old Baldy Club residence, a mounted photo reproduction of President Ronald Reagan, and a photograph of Mr. Rippey at a theatre opening.
