1. Be it enacted by the Student Senate of the Associated Students of the

- 2. University of Wyoming that whereas the student body in the recent ASUW
- 3. General Election defeated the WyPIRG referendum by a 2-1 margin, and
- 4. whereas the ASUW Government has already invested countless hours, and over
- 5. \$1,000 in the WyPIRG effort to no avail, and whereas the new ASUW Student
- 6. Consumer Committee will become part of the ASUW Constitution upon Trustee
- 7. approval, Therefore no ASUW funds or resources may be used by any member of
- 8. the ASUW Government in any manner or instance which may directly or indirectly
- 9. aid, assist, or further the organization known as WyPIRG, or any equivalent
- 10. autonomous, semi-autonomous, or extra-ASUW organization espousing similar
- 11. objectives. Further, Be it enacted by the Student Senateof the Associated
- 12. Students of the University of Wyoming that all ASUW administrators and
- 13. administrative sub-units are equally enjoined from such use of ASUW funds
- 14. and resources for the aid, assistance or furtherance of WyPIRG or equivalent
- 15. organizations. This bill will become effective immediately upon the
- 16. approval of the ASUW Senate and President, and will continue in force for
- 17. the remainder of the 1983 fiscal year (ends June 30, 1983) and for the
- 18. entirety of the 1984 fiscal year (July 1, 1983 to June 30, 1984).

After a great deal of consideration, I have decided to veto Senate Bill #1448, "The Last Word on WyPRIG", passed by the ASUW Senate April 26, 1983. I share many of the concerns that were voiced by some senators at the metring, but more particularly I'm concerned that the bill sets a dangerous precedent for student government here at the University of Wyoming. Furthermore, I believe the bill violates the Freedom of Speach and Association, as protected by the First Amendment to the United States Constitution.

As student leaders, we must always encourage student participation and keep in touch with what is going on around us on Campus. We cannot hide behind a moratorium to cut off debate on the WyPIRG issue for a year, or for that matter, any other issue which may arise.

The sentiment of the majority in the senate meeting supported passage of Bill #1448 on the grounds that the WyPIRC issue has wasted a great deal of their time. Yet, as elected student representatives, it is our duty to entertain new ideas, discuss their potential, and approve or disapprove them according to their merits and our own consciences.

In the last election, the student body of the University of Wyoming rejected the WyFIRG proposal and approved the creation of the ASUW Student Consumer Committee. I am committed to the vote of the students, and will work diligently in the coming year with the Senate to promote the success of the Student Consumer Committee. The establishment of the Student Consumer Committee is hardly an excuse to cut off all debate on the WyFIRG issue, ignoring the controversy in the hope it will go ever.

I stend firmly behind my carlier statements that the only way to put WyFIRG to rest completely is to establish a good ASUW Student Consumer Committee and make sure that committee accompletes its objectives. I would suggest that the committee members who are living here in Laranie this summer meet and begin work on a project to be completed as soon as students return next fall. The students will then see that our committee means business and will, in fact, do what it says it will do. This will truly be the last work on WyFIRG.

I believe that less intrusive alternative means exist for dealing with controversial issues than to cut off all debate. If the Senate is concerned over the amount of time and expense being devoted to the WyPIRG issue, I recommend that the Senate parsue a parlimentary course at each meeting WyPIRG is raised, cutting off debate only after ideas have been discussed fully.

Forthermore, if the Senate is opposed to funding WyPIRG, they can withold their consent as they do with any other appropriation request.

The ASUW is the appropriate forum to present proposals like WyPIRG. When students contribute student fees they expect, and rightly so, to have a say in where their money will be spent. The moratorium on WyPIRG is a denial of this right. Instead of putting up "stone walls" to student speech and contribution, we should be enlisting student help and ideas to make the Student Consumer Committee work. I now encourage all Senators, students endorsing WyPIRG, and students endorsing the Student Consumer Committee to join forces and make the ASUW Student Consumer Committee a success.

A college campus abould remain "the market place of ideas", a center for the exchange of ideas and philosophy. "The last Word on WyPIRG' places a one year moratorium on any proposal brought to us by a fully recognized group on Campus or any other "extra ASUV organization espousing similar objectives." This bill serves as a prior restraint to their right to free speach and association. The Bill sets a dangerous precedent. For example, if the student navepaper prints an unfavorable account of ASUV, are we to discontinue their funding and resuse them an audience? What about other clube?

Our treatment of all the clubs and organizations here at the University of Vyoning should be equal.
