1. Be it enacted by the Student Senate of the Associated Students of the
2. University of Wyoming that the ASUW budget for FY 1984-85 (attached)
3. be approved for the sum of \$408,580.00. Be it further enacted that:
4. -\$20,000 be taken from the ASUW Reserve Fund for the purchase of an ASUW
5. computer system that will be compatible with the Administrations system
6. to be used by ASUW Offices;-the Activities Program be operated as set forth
7. Spring Semester 1984 and approved by the ASUW Senate; -any concert
8. programming be done in conjunction with the Finance Budget and Planning
9. Committee; -the Finance Budget and Planning Committee feels that it is
10. imperative that a system for collection, analyzation, and dissemination of
11. data be established and maintained for proper planning and organization
12. of ASUW units.
