UNIVERSITY REGULATION 403. Revision 1

Initiating Authority: Vice President for Academic Affairs

Subject: Final Examination Policy

References: (a

- (a) Regulations of the Trustees of the University of Wyoming, Chapter IV (Republished Ed., August 1, 1978)
- (b) University Regulation 403 (Sept. 13, 1978)
- (c) Faculty Senate Bill 125 (adopted Nov. 5, 1979)
- 1. Purpose: To revise final examination policies and procedures in reference (b) by incorporating the recommendations of reference (c), that: the schedule of final examinations be subject to approval of the Vice President of Academic Affairs; Saturday, Sunday or holiday may be the day free of classes preceding the first day of final examinations; and an additional four hours be allowed for submission of final grades to the Registrar's office.

## 2. Final Examination Schedule:

- a. The Registrar is authorized to schedule final examinations subject to the approval of the Vice President for Academic Affairs. With only the exceptions specifically designated below, exams will be given at the times thus designated and no other times. The examination schedule shall be published at least one month before the first day of final examinations.
- b. Exceptions for which no examination time will be shown in the Final Examination Schedule are: (1) all Military courses; (2) P.E. Activity courses; (3) band, choir, chorus, orchestra and individual lessons; (4) all courses listed entirely as TBA; (5) courses blocked first half of semester; (6) courses meeting off campus; (7) correspondence and extension courses; (8) student teaching; (9) labs, discussions and recitations; (10) courses meeting after 4:59 p.m.; (11) School of Religion courses; (12) courses where the department head and dean have given timely approval for no final examination; and (13) courses beginning with 700 in the College of Education which meet after 2:59 p.m.
- c. In courses in which the same material is taught in more than one section and a common examination is deemed desirable, a group examination will be scheduled by the Registrar if such can be arranged within the limits of the examination period and without creating serious conflicts. Request for such a group examination, affirming that a common examination will be given, shall be made to the Vice President for Academic Affairs.

Vice President for Academic Affairs when recommended by the instructor, the appropriate department or division head, and the dean.

i. This policy shall be effective beginning with the 1980 Fall semester final examination period.
