Thesis: A fee increase assessed to all students attending the University of Wyoming for the operation of the Intramural-Recreational Sports Program and facilities which support the program operation.

in part covered with part-time student help which effectively increases the loss of
of revenue to \$30,000. or more. Federal Work Study help allotted to the program
has also been cut by \$20,000 over the past two years requiring more student help to
be paid with student fee dollars. Inflation has also increased the costs of goods and
services required to operate the program. The increase in enrollment in Fall, 1987, has
also resulted in increased participation which requires increased funds to continue to
make the program available to all students.
