- contractual agreement proposed by the Student Publications
- 20 Board is officially rejected; and

- in the addendum is offered as a formal counter-proposal.

# COUNTER OFFER TO STUDENT PUBLICATIONS BOARD PROPOSAL FOR RENEGOTIATION OF CONTRACTUAL AGREEMENT BETWEEN ASUW GOVERNMENT AND STUDENT PUBLICATIONS BOARD

#### **BACKGROUND**

- 1. The Student Publications Board currently has a contractual agreement with ASUW to repay the purchase of the 1986 Compugraphic Typesetting equipment. The original contract called for a ten year payback period of \$14,000 annually to begin FY 88. The Student Publications Board defaulted on this first payment.
- 2. In the early fall of 1988, a deficit operating account for Student Publications was discovered. This account was replaced by new accounts but was never officially closed. This account totaled \$180,905.55 in 1988.
- 3. The above deficit account has been appropriately closed through a transfer of funds from the ASUW Reserve. Student Publications has made \$12,000 annual payments from FY 90 through FY 95 which will total a repayment of \$72,408.00 by June 30, 1995. In addition to this payment, a weekly half page of advertising has been given to ASUW in lieu of interest on the loan.
- 4. The remaining balance in the loan amounts to \$107,592.00 as of June 30, 1995.

### **PROPOSAL**

- 1. The payment of the principal is renegotiated in the following way: an \$8,000.00 annual payment will be made beginning FY 96 for the next 13.5 years.
- 2. The payment of interest on the loan will continue to be paid through the ASUW Advertising Exchange. However, instead of having a half page of advertising space available weekly that totals approximately \$4,000.00 annually, an account shall be established to monetarily equal the product of the price for a 5"X 7" ad for the student publications publishing period of 35 weeks. The ASUW Presidential designee shall draw from this account and allocate this space on an as-needed basis not exceeding a full page of advertising in any one week to accommodate for the fluctuation of activities in any given period.
- 3. Any renegotiations, alterations, or severances involving this agreement do not invalidate the remaining portions.
- 4. Any portions of the previous agreement not specifically addressed by this document remain valid and binding.

## **CONDITIONS**

- 1. This contract will be binding upon the ASUW Student Government and the Student Publications Board. Upon rejection, the present contract will remain in place as is.
- 2. This contract will be fulfilled at the end of the aforementioned 13.5 years when the loan amount of \$107,592.00 is fully repaid.
