- WHEREAS, Section III of the Rules and Procedures of the Student Senate of the
- 2 Associated Students of the University of Wyoming states that a Senator will be removed
- 3 from office after no more than 3 absences; and
- 4 WHEREAS, Section IV does not state that the ASUW Secretary will forward all
- 5 legislation to the ASUW Steering Committee; and
- 6 WHEREAS, Section IV, B. states that a file of all bills and resolutions will be maintained
- 7 in the ASUW Office and that a card index will be maintained by the ASUW Secretary;

- 9 WHEREAS, Section V, F. states that legislation will be kept in a volume of legislation by
- the ASUW Secretary; and
- WHEREAS, Section VI, A, 1. states that any member of ASUW can be recognized by the
- 12 presiding officer.
- 13 THEREFORE, be it enacted by the Student Senate of the Associated Students of the
- 14 University of Wyoming, that the Rules and Procedures of the Student Senate of the
- Associated Students of the University of Wyoming, as revised by the ASUW Constitution

- 16 Committee supersede all previous Rules and Procedures and be recognized as the official

# RULES AND PROCEDURES CHANGES (overview)

#### Section III

Replace "No more than three absences shall be permitted before removal from office" with "Any senator with three or more absences shall appear before the ASUW Steering Committee to determine whether they can continue serving."

## Section IV, A.

Line 12 will be inserted to read "The ASUW Secretary will forward all legislation to the ASUW Steering Committee so that it can refer the proposed ASUW legislation to the proper ASUW permanent or special committee for specified action or recommendation." Line 12 will be renumbered to Line 13.

## Section IV, B.

#### Will now read:

Records: A record of all bills and resolutions passed shall be maintained in the ASUW Office. These shall be listed according to number. Each bill or resolution shall state the following:

Between "any member of the ASUW and may address," add "after being yielded the floor by an ASUW Senator, Vice President, or ex-officio member."
