Title: Professor Evaluations Online

1. WHEREAS, there is currently no system in place where students can access

2. information about courses and professors; and

3. WHEREAS, this information about courses should include student reviews of

4. their professors, information on a professor and his/her teaching styles,

5. withdraw rates, and class size; and

6. WHEREAS, this information would provide a valuable asset to students in

7. selecting their courses; and

8. WHEREAS, this information would serve as a valuable asset to faculty in

9. advising students; and

10. WHEREAS, a better comparison could be made between courses and

11. professors if this information was available; and

12. WHEREAS, students would be able to choose courses and professors that are

13. best suited for the way in which they learn; and

14. WHEREAS, having this information available would also increase course

15. retention rates, because students can preview a course and the professor before

16. enrolling; and

17. WHEREAS, the Pick-A-Prof company provides a service that makes this

18. information available to all students and faculty year around; and

- 19. WHEREAS, Pick-A-Prof also is an unbiased third party which posts
- 20. evaluations in addition to reading and screening student reviews for profanity
- 21. and personal attacks on professors, and moves liability away from the
- 22. University.
- 23. THEREFORE, be it enacted by the Student Senate of the Associated Students
- 24. of the University of Wyoming that an implementation committee be created
- 25. (see Attachment A) to oversee and implement the Pick-A-Prof program at
- 26. the University; and
- 27. THEREFORE, be it enacted by the Student of the Associated Students of the
- 28. University of Wyoming that ASUW allocate \$5,000 annually for the services
- 29. of the Pick-A-Prof program, contingent upon the completion of the work of
- 30. the Implementation Committee; and
- 31. THEREFORE, be it further enacted by the Associated Students of the
- 32. University of Wyoming that the ASUW Academics and Technology
- 33. Committee annually review the Pick-A-Prof service and make a
- 34. recommendation to the Senate thereafter; and
- 35. THEREFORE, be it further enacted by ASUW that the need for the inclusion
- 36. of past grading history of professors will be reviewed in the Spring of 2005 by
- 37. the Academics and Technology Committee.
