- 15. Wyoming that the school colors be officially returned to brown and gold; and

- 17. marketing campaign the colors of the University apparel, merchandise, and
- 18. athletic uniforms be changed back to the original brown and gold.

Re: UW Tradition - Some History

Dear Editor:

Kudos to the ASUW on their adoption of a resolution to bring back our University's traditional colors of brown and gold. I was shocked and disappointed by President Dubois' e-mail response to the ASUW. President Dubois' response continues his irreverent disregard for tradition, on this matter, trashing historical UW tradition by commercializing traditions deemed sacred by many of us alums. Dr. Dubois further justifies his unwelcome changes by citing the increase in marketing success of apparel sales bearing the "new colors", and asserts that the change is a done deal, ignoring where the traditions originated in the first place!

From whence come the historical symbols of our Alma Mater? Professor Wilson O. Clough, in his treatise, "History of the University of Wyoming, 1887-1964, page 38, (available at the Albany County library.), records, and I quote in pertinent part:

". . . At the March meeting the Board adopted the official seal of the University: 'in circular form with the words, 'The University of Wyoming, Laramie' in circular form between two gold cords, and in the center of the seal, an open book with a quill pen diagonally across the book and word 'Equality' underneath the book on the center of the seal." (Emphasis, mine).

(Continuing), Less officially, the University colors of brown and yellow were selected some time before 1892. Dean Soule later recalled that he was on the committee for their selection, perhaps with Nelson and Miss Hebard, and that they had difficulty making a decision. Soule kept a saddle horse at the time, and as he was riding one Saturday he came upon a dale filled with brown-eyed Susans. Struck with the color, he picked a bunch and presented them to the committee with his suggestion. Thus the brown and yellow of Wyoming." (Emphasis again, mine.).

And that's where this all began. Tradition, tradition!
